A BILL INTITULED

An Act to amend "The Otago Education Reserves Title. Abandonment Act 1868."

HEREAS by "The Otago Education Reserves Abandonment Act Preamble. 1868" hereinafter referred to as "the said Act" it was among other things enacted that the said Act should not come into operation until reserves proved to the satisfaction of the Governor in Council to be 5 of at least equal value in the aggregate to the reserves by the said Act authorized to be relinquished should have been granted to trustees appointed under certain Ordinances of the Superintendent and Provincial Council of the Province of Otago in the said Act mentioned And whereas the said provision is inconvenient and it is expedient 10 that the same should be repealed

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows-

1. The Short Title of this Act shall be "The Otago Education Short Title. 15 Reserves Abandonment Act 1870."

2. The sixth section of the said Act is hereby repealed.

3.
