A BILL INTITLED

AN ACT to enable the Otago Education Board to borrow *Title.*
any sum not exceeding Twenty Thousand Pounds,
for the erection and extension of School Buildings.

WHEREAS the lands specified in the Schedule hereto have, under *Preamble.*
and by virtue of several Ordinances of the Superintendent
and Provincial Council of the Province of Otago, been from time to
time set aside and appropriated for the general advancement of
education in the said Province: And whereas by virtue of "The
5 Education Ordinance, 1862," of the Superintendent and Provincial
Council of the aforesaid Province, the Superintendent and the
Members of the Executive Council for the time being, together with
the Speaker of the Provincial Council of the said Province, were
constituted a Board by the name of "The Otago Education Board:"
10 And whereas the said Board has been intrusted with the management
of the above-mentioned lands, and the administration of the rents and
proceeds thereof: And whereas it is expedient to enable the said
Board to borrow money on the security of the aforesaid lands for the
purpose of extending existing school buildings, and of erecting new
15 school houses and buildings in various places throughout the entire
Province:

BE IT THEREFORE ENACTED by the General Assembly of New
Zealand in Parliament assembled, and by the authority of the same,
as follows:—

Short Title.

1. The Short Title of this Act shall be "The Otago School Buildings Loan Act, 1873."

Power to borrow sum not exceeding £20,000, to be applied in buildings.

2. The Otago Education Board, hereinafter called "the Board," may, for the purpose of extending existing school buildings, and erecting new school houses and buildings, borrow at interest any sum 5 of money not exceeding in the whole the sum of twenty thousand pounds, and may expend and apply the same accordingly.

Moneys borrowed to be secured by mortgage.

3. In respect of the moneys to be borrowed or taken up under this Act. the Board may grant to the person or persons lending the same one or more mortgages upon all or any part of the lands 10 described in the Schedule hereto, in such form and subject to such conditions, and with such powers and provisions, as the said Board may think fit and expedient.

Power to borrow to redeem loan at date fixed for repayment.

4. If at the time appointed by any mortgage for the payment of the principal money secured thereby, the Board is unable to pay off 15 the same, it may, if it shall think fit, borrow such sum of money as may be necessary for the purpose of paying off the whole or any part of such principal money, and may secure the repayment of the same and the interest to be paid thereon in manner hereinbefore authorized in regard to the moneys originally borrowed under this Act. 20

A BILL INTITULLED

AN ACT to amend the Law relating to the Sale, Letting, Title. and Occupation of the Waste Lands of the Crown within that part of the Province of Otago formerly included in the Province of Southland.

WHEREAS it is expedient to reduce the price of land, and to Preamble.
provide for the sale of portions thereof upon deferred payments,
in that part of the Province of Otago which was formerly included
within the boundaries of the late Province of Southland:

5 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act shall be "The Otago Waste Lands Short Title.
Act, 1873."

10 2. It shall be lawful for the Superintendent to cause all the waste lands of the Crown within the said district, and not included within any hundreds now existing, to be classified as rural land and pastoral land respectively, and such classification shall be made by Commissioners appointed for that purpose by the Superintendent, and of such 15 Commissioners the Chief Surveyor of the district shall be one, and such Commissioners shall, within six months from the date of their appointment, furnish to the Superintendent a description of the boundaries of the land so classified by them as agricultural land and as pastoral land respectively, which description shall be published in the Otago Provincial Government *Gazette*, and after such publication the land therein described shall for the purposes of this Act be deemed to be agricultural land or pastoral land in accordance with such description.

Price of agricultural land to be forty shillings.

Pastoral land to be twenty shillings.

Land in hundreds to be twenty shillings per acre.

Governor, on recommendation of Provincial Council, may raise price.

Superintendent may make temporary reserves pending meeting of Provincial Council.

Superintendent and Provincial Council may set aside lands within existing hundreds for sale on deferred payments in terms of "The Otago Waste Lands Act, 1872."

Laws in force at passing of "The Otago and Southland Reunion Act, 1870," to remain in force unless repugnant to this Act.

3. From and after the date of the publication of the aforesaid description of agricultural land and pastoral land in the Otago Provincial Government *Gazette*, the price of agricultural land within the aforesaid district shall be forty shillings per acre, and the price of pastoral land within the aforesaid district shall be twenty shillings per acre, and the price of land within the hundreds now existing within the said district shall be, except as hereinafter provided, twenty shillings per acre: Provided always, that if at any time the Superintendent and the Provincial Council of Otago shall recommend the Governor to raise such price, then it shall be lawful for the Governor in Council, if he shall see fit, to raise such price over the whole or any part of the said district in accordance with such recommendation.

4. It shall be lawful for the Superintendent of Otago temporarily, and pending the meeting next ensuing of the Provincial Council, to set aside and reserve from sale such blocks of land within the said district as he shall see fit: Provided that such temporary reservation shall be null and void after the termination of the Session next ensuing of the Provincial Council.

5. It shall be lawful for the Superintendent, with the advice and consent of the Provincial Council, to set aside lands within the now existing hundreds in the said district for sale on deferred payments, such lands to be sold and dealt with in terms of and subject to the conditions and provisions embodied in sections forty-seven to sixty-four inclusive of "The Otago Waste Lands Act, 1872." Provided that whenever in the said sections of "The Otago Waste Lands Act, 1872," the following words are used, they shall bear the meanings hereinafter severally assigned to them, that is to say:—The words "District Officer" shall mean the Commissioner of Crown Lands for that part of the Province formerly included in the boundaries of the late Province of Southland; and the words "Waste Lands Board" shall mean the Waste Land Board for the part of the Province of Otago formerly included in the boundaries of the Province of Southland being the Waste Lands Board appointed under the provisions of "The Southland Waste Lands Act, 1865."

6. The laws regulating the sale letting and occupation of the waste lands of the Crown within the district aforesaid in force at the time of the passing of "The Otago and Southland Reunion Act, 1870," shall continue to be in force in so far as they are not repugnant to the provisions of this Act.
