BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows:-

1. This Act may be cited as the Shops and Offices Amendment Short Title. Act, 1919, and shall form part of and be read together with the Shops and Offices Act, 1908.

2. Section two of the Shops and Offices Amendment Act, 1910, Repeal.

10 is hereby repealed, and the following substituted in lieu thereof:—

Interpretation.

"2. In this Act, if not inconsistent with the context,—

"' Hotel' means any premises in respect of which a publican's license is granted under the Licensing Act, 1908, and

includes a chartered club:

"'Restaurant' means any premises (other than an hotel) in which meals or refreshments are provided and sold on the premises, and whether or not lodging is provided for hire for the accommodation of persons who desire to lodge therein, and includes marble-bars, soda-fountains, softdrink shops, tea-rooms, and oyster-saloons.

"'Private hotel or boardinghouse' means any premises other than an hotel or restaurant, and includes a lodging-house, and means a house in which five or more paying boarders or lodgers, not being members of the proprietor's family,

are accommodated."
