## A BILL INTITULED

AN ACT to make Better Provision for controlling the Title. Sale of Stock-remedies.

BE IT ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as the Stock-remedies Act, Short Title and 1932, 1932-33, and shall come into force on the first day commencement. of June, nineteen hundred and thirty-three.

2. In this Act, unless the context otherwise requires,— Interpretation. "Analysis" includes the bacteriological examination of vaccines, sera, and other biological products; and "to analyse" has a corresponding meaning:

8. (1) For the purposes of this Act there shall be stock-remedies appointed a Board to be called the Stock-remedies Registration Board Registration Board.

(2) The Board shall consist of—

(a) The Registrar, who shall be appointed by the Governor-General from among the veterinary surgeons in the employment of the Department of Agriculture:

(b) One person to be appointed on the recommendation of the incorporated society known as the New Zealand Veterinary Association (Incorporated):

(c) One person to be appointed on the recommenda-

tion of the Pharmacy Board of New Zealand.
(3) The members of the Board other than the 15 Registrar, who shall hold office during pleasure, shall be appointed by the Governor-General for a period of three years, save that any such member may be reappointed, or may be at any time removed from office 20 by the Governor-General for disability, insolvency, neglect of duty, or misconduct, or may at any time resign his office by writing addressed to the Registrar.

(4) If any member of the Board other than the Registrar dies, resigns, or otherwise vacates his office, 25 the vacancy so created shall, within two months after the occurrence thereof, be filled in the manner in which the appointment to the vacant office was originally made. Every person so appointed shall hold office for the residue of the term for which his predecessor was 30 appointed.

(5) The members of the Board, other than the Registrar. shall be paid such allowances as may be lawfully appointed and all travelling-expenses reasonably incurred by them in respect of attendance at meetings of the Board or in

35 transacting the business of the Board.

(6) In the absence of the Registrar from any meeting of the Board any officer of the Department of Agriculture may be appointed by the Registrar to act as his deputy, and while so acting shall for the purposes of this Act have 40 all the powers of the Registrar.

4. (1) The Registrar shall be the Chairman of the Meetings of Board

(2) Meetings of the Board shall be held at such times and places as the Board or the Chairman may appoint.

(3) The Board may regulate its procedure in such manner as it thinks fit.

Appointment of Analysts and Inspectors. 5. There may from time to time be appointed, as officers of the Public Service, such Analysts and Inspectors as are required for the purposes of this Act, who shall have the powers and shall perform the duties hereinafter set out, and such further powers and duties as are prescribed.

Registration of stock-remedies.

- 6. (1) Before any stock-remedy is sold, it must be registered in accordance with the provisions of this Act and of regulations thereunder.
- (2) A stock-remedy may be registered by the Board 10 for a period of three years, and may from time to time be re-registered for a similar period in the same manner and with the same consequences in all respects as in the case of the original registration.
- (3) Application for the registration of a stock-remedy 15 shall be made in writing in the prescribed form addressed to the Registrar, and containing or accompanied by the following particulars:—

(a) The name of the stock-remedy:

(b) The trade-mark or all the trade-marks (if any) to 20 be used in respect of the stock-remedy:

(c) A description of the composition of the stockremedy, showing in respect of each ingredient its name, the form in which it occurs, and the proportion of it present in the stock-remedy, 25 or showing in the case of vaccines, sera, or other biological products the method of preparation:

Provided that it shall not be necessary to show the proportions of ingredients for which 30 no specific efficacy is claimed and which are shown under the heading "adjuvants", "emulsifiers", or "inert ingredients", or any other appropriate heading, as the case may be:

(d) The preventive or remedial properties claimed in 35 respect of the stock-remedy:

(e) A specimen copy of every label or advertisement to be used or published in respect of the stockremedy.

(4) Every such application shall be verified by the 40 statutory declaration of the applicant, and shall be accompanied by the prescribed fee.

(5) The proportion of any ingredient required to be shown by paragraph (c) of subsection three hereof shall be the minimum proportion, except in the case of 45

ingredients which are poisons within the meaning of the Poisons Act, 1908, when the maximum as well as the minimum proportion shall be shown. Every such proportion shall be stated as a percentage by weight in the case 5 of a solid stock-remedy, and as a number of grams per hundred cubic centimetres in the case of a liquid stockremedy. For the purposes of this subsection a semi-fluid stock-remedy shall be deemed to be solid if recommended for use by weight (whether or not it is also 10 recommended for use by volume) and in all other cases shall be deemed to be liquid.

(6) The applicant shall furnish such certificates of analysis, and such experimental evidence or other evidence whatsoever, as the Board may require in 15 support of any statement contained in the application or in any specimen copy of a label or advertisement deposited under paragraph (e) of subsection three hereof, and the Board may refuse to register the stock-remedy if it is of opinion that any such statement is inaccurate, 20 inadequate, or misleading, or otherwise not in compliance with the provisions of this Act, and cannot be conveniently omitted, altered, or amplified so as to comply therewith, or it may refuse to approve any such label or advertisement which in the opinion of the Board 25 contains any such inaccurate, inadequate, or misleading statement or is otherwise not in compliance with this

(7) The Board may refuse to register any stockremedy which contains incompatible or volatile in-30 gredients, or which is likely, in the opinion of the Board, to be injurious to stock.

7. Every proprietor or vendor of a stock-remedy stock-remedies commits an offence who sells such stock-remedy—

(a) Before he has received from the Registrar in the case of the proprietor a certificate of the registration of the stock-remedy, or in the case of any other vendor a notification that the stock-remedy has been registered by the proprietor; or

(b) After the period of registration specified in the last such certificate or notification received by him has expired.

8. (1) Every proprietor or vendor of a stock-remedy commits an offence who during the period of any registration thereof sells such stock-remedy otherwise than in a receptacle which bears or has attached thereto a label of which a specimen copy has been deposited with the Registrar and approved by the Board for such period of registration, and which shows clearly and distinctly (with such other matter as the Board may approve) the following particulars:—

(a) The name and address of the proprietor of the 10

stock-remedy:

(b) The name of the stock-remedy, and the trademarks (if any) under which it is sold:

(c) In the case of a solid the minimum net weight, and in the case of a liquid the minimum net volume, 15

of the contents of the receptacle:

(d) The description of the composition of the stockremedy as shown in the application for registration, or such summary thereof as the Board may approve:

(e) Such other particulars as may be prescribed.

(2) Every proprietor or vendor of a stock-remedy commits an offence who during the period of any registration of the stock-remedy uses or publishes, or permits or causes to be used or published, in respect 25 of the stock-remedy any label or advertisement of which a specimen copy has not been deposited with the Registrar and approved by the Board for such period of registration, or which differs in any material respect from such specimen copy.

provided that nothing in this subsection shall be construed to make it an offence to use or publish during the period of any registration of a stock-remedy any advertisement that does not differ in any material 35 respect, with regard to the preventive or remedial properties claimed in respect of the stock-remedy, from a specimen copy deposited as aforesaid and approved by the Board for such period of registration.

(3) A label or advertisement relating to any regis- 40 tered stock-remedy may, in accordance with the provisions of this Act and of regulations thereunder, be approved by the Board for the period of the registration of the stock-remedy. An application for such approval may be combined with an application for the registration 45

of the stock-remedy or may be made subsequently at any time during the period of registration. Every such application shall be made in writing in the prescribed form addressed to the Registrar, and shall be accom-5 panied by the prescribed fee. The provisions of subsection six of section six hereof shall, so far as applicable, apply to every such application.

(4) No reference shall be made in any label or advertisement to the registration of a stock-remedy, except in 10 the words "Registered pursuant to the Stock-remedies Act, 1932". No reference shall be made in any label or advertisement to the approval of such label or advertisement or of any stock-remedy by the Board, the Registrar,

or the Department of Agriculture.

9. Every proprietor or vendor of a stock-remedy is Selling under liable on summary conviction to a fine of fifty pounds false label. who sells such stock-remedy in a receptacle which bears or has attached thereto a label the particulars in which do not materially correspond with the particulars of

620 the contents of the receptacle.

10. In every sale or contract for the sale of any Implied stock-remedy by the proprietor or a vendor there shall be warranty by proprietor. implied a warranty by the proprietor of the stock-remedy (whether or not he is otherwise a party to the sale or 25 contract) to the purchaser that the stock-remedy is reasonably fit for any purpose for which its use is expressly or impliedly suggested in any label or advertisement used or published in respect of the stock-remedy by or with the concurrence of the proprietor.

11. (1) An Inspector may at all reasonable times enter Power of upon the premises of the proprietor or of any vendor of a Inspectors to take samples. stock-remedy, and may, without payment, take a sample

of such stock-remedy.

(2) Every person who obstructs an Inspector in the 35 exercise of his powers under this section is liable on summary conviction to a fine of ten pounds.

12. (1) Every sample taken by an Inspector shall be How sample to taken in the presence of the proprietor or vendor if he is available, or if he is not available, then in the presence of

40 some other witness.

(2) The Inspector shall divide each sample into three parts, and seal each part separately with an official seal, in the presence of the proprietor or vendor or his agent whenever possible or of another witness.

(3) He shall leave with or deliver to the proprietor or vendor one part, and shall deliver a second part to an

Analyst; the third part shall be retained by the Inspector, and shall be sealed by the proprietor or vendor if he is ald present and so desires labor the territories the setting

(4) Delivery of a sample to an Analyst or to a proprietor or vendor may be effected personally by the Inspector, or by posting by registered post to the usual address of the Analyst, proprietor, or vendor, as the case may be.

Analysis of sample and certificate of Analyst.

13. (1) The Analyst shall, on receiving the sample, divide it into two approximately equal portions, one of 10 which he shall fasten up and seal in a suitable vessel for production, if required, in any proceedings that may thereafter be taken in the matter.

(2) He shall analyse the remaining portion, and shall set out the result in a certificate of analysis in the pre- 15

scribed form.

(3) The result of the analysis shall be compared with the particulars in the label of the receptacle from which the sample is taken or with the particulars in the application for the registration of the stock-remedy from 20 which the sample is taken, and if there is a discrepancy in any respect between the result of the analysis and the aforesaid particulars the Analyst shall add to the certificate of analysis a certificate as to whether such discrepancy is materially to the prejudice of a purchaser.

(4) Where on analysis and comparison a discrepancy materially prejudicial to a purchaser is found in any sample, a copy of the Analyst's certificate shall be forwarded to the proprietor and also to the vendor (if he is not the proprietor) of the stock-remedy from which the 30 sample is taken. In any other case the proprietor or the vendor may obtain a copy of the Analyst's certificate on

paying the prescribed fee.

14. (1) The purchaser of any stock-remedy may at any time notify an Inspector in writing that he desires 35

him to take a sample of such stock-remedy.

(2) On payment of such fee as is prescribed the Inspector or some person authorized by him in writing shall attend at the place mentioned in the notice and take a sample of the stock-remedy and deal with the 40 sample in the manner directed in section twelve hereof.

(3) Not less than four clear days' notice shall be given to the vendor of the stock-remedy, and also to the proprietor thereof if he is not the vendor, by the Inspector of the time and place at which he intends to take such 45 sample.

Analysis on request of buyer.

(4) The vendor and the proprietor or their respective agents shall be at liberty to attend at the time and place specified in such notice.

(5) The Inspector shall satisfy himself as far as possible 5 that the receptacles containing the stock-remedy are in a sound condition, that they have been properly stored, and that they have not been opened or tampered with in

(6) The Analyst shall analyse the sample and give a 10 certificate or certificates as mentioned in section thirteen hereof to the Inspector. A copy of the Analyst's certificate shall be forwarded to the purchaser; and copies thereof shall also be forwarded to or be obtainable by the proprietor and the vendor as provided in subsection four 15 of the said section thirteen.

(7) If the result of the analysis shows that the stockremedy is not materially at variance with the particulars in the label of the receptacle from which the sample is taken, the vendor and the proprietor shall be entitled to 20 any reasonable expenses to which they may respectively have been put in attending at the place at which the sample is taken, and may recover such expenses from the

purchaser as a debt.

15. (1) In any proceedings under this Act the pro- Analyst's 25 duction by the prosecutor of a certificate of analysis certificate purporting to be signed by an Analyst shall, without evidence. proof of the signature of the Analyst, be sufficient evidence of the facts stated therein, unless the defendant requires that the Analyst be called as a witness, in which 30 case he shall give notice thereof to the prosecutor not less than three clear days before the date of the hearing.

(2) In like manner the production by the defendant of a certificate of analysis purporting to be signed by an Analyst shall, without proof of the signature of the 35 Analyst, be sufficient evidence of the facts stated therein, unless the prosecutor requires that the Analyst be called

(3) A copy of such last-mentioned certificate shall be sent to the prosecutor at least three clear days before the 40 date of the hearing, and if it is not so sent the Court may adjourn the hearing on such terms as it thinks

16. The Court may order that the part of the sample Independent retained by the Inspector under section twelve hereof be analysis.

divided into two parts in the presence of the defendant or his agent and that each of such parts be submitted to an independent analyst for report.

Tampering with sample.

17. Every person is liable on summary conviction

to a fine of fifty pounds who-

(a) Knowingly and fraudulently tampers with any stock-remedy so as to procure that a sample of it taken in pursuance of this Act is not a fair sample of the stock-remedy:

(b) Improperly breaks the seal of or tampers with any 10 part of a sample taken in pursuance of this Act.

General fines.

18. Every person who commits an offence against this Act for which no penalty is elsewhere prescribed is liable on summary conviction for the first offence to a fine of ten pounds, and for every subsequent offence to a fine of 15

fifty pounds.

Publication of results of analysis and

19. The Board may from time to time publish in such manner as it thinks fit the results of any analysis made under this Act, or the results of any experiments made with any stock-remedy sold in New Zealand, or 20 any other matter whatsoever relating to any such stockremedy, and neither the Board, the Registrar, nor the other members of the Board, nor the Government Printer, nor any person shall be liable in any way in respect of such publication.

20. All fees and other moneys paid under this Act shall be paid into the Public Account, and shall form part of the Consolidated Fund, and all expenses incurred in respect of the administration of this Act shall be paid out of moneys to be from time to time appropriated by 30

Application of

21. (1) The Governor-General may from time to time, by Order in Council, make regulations—

(a) Governing the registration of stock-remedies and the approval of labels and advertisements 35 under this Act:

(b) Prescribing the forms required under this Act:

(c) Prescribing the fees payable under this Act:

(d) Prescribing particulars to be shown in labels of receptacles containing stock-remedies:

(e) Prescribing methods of taking samples and of analysis and of experiments with stock-remedies:

(f) Prescribing limits of error allowable in setting out in applications for registration and in labels the proportions of ingredients present in stock- 45 remedies:

(g) Prescribing the powers and duties of Analysts and Inspectors:

(h) Providing for the licensing of vendors of stockremedies, and the issue, renewal, revocation, and cancellation of licenses:

(i) Prescribing the forms of such licenses, the qualifications of applicants therefor, the conditions upon which they may be issued or to which they shall be subject, and the fees payable in respect thereof:

(j) Prohibiting any person from acting as a vendor of any stock-remedy except in pursuance of a license in that behalf and in accordance with regulations under this Act:

(k) Prescribing fines, not exceeding twenty pounds in any case, for failure to comply with the provisions of any regulations under this Act or with any condition to which a vendor's license is subject:

20 (1) Prescribing any other matters for which regulations are contemplated or required by this Act, or which he deems necessary for the efficient administration thereof.

(2) All such regulations shall be published in the 25 Gazette, and shall be laid before Parliament within ten days after publication, or if Parliament is not then sitting, then within ten days after the commencement of the next ensuing session.

22. Nothing in this Act shall be construed to limit Poisons Act 30 the provisions of the Poisons Act, 1908, or of the Dangerous Drugs Act not Drugs Act, 1927, or of any regulations thereunder.
