# Supplementary Order Paper

ANIMAL PRODUCTS BILL

*Proposed Motion to Divide Bill into 2 Separate Bills*

Hon JOHN LUXTON, in Committee, to move as follows:

That *Parts 1 to 10 and Schedule 1* be a separate Bill with the following Title, enacting words, and clause:

**An Act to replace the Meat Act 1981, and to reform and restate the law relating to the processing of animal material into products for use, trade, and export**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Animal Products Act 1999.

(2) This Act comes into force on **1 November 1999**, except for **Part 2**.

(3) **Part 2** comes into force on such date or dates as may be appointed by Order in Council, and for this purpose—

(a) Different dates may be appointed for different provisions; and

(b) Different dates may be appointed for different classes of animal material or products, animal product businesses, operations, or other purposes.

(4) To the extent not previously brought into force under **subsection (3), Part 2** comes into force on **1 November 2002**.

(5) The application of any provision brought into force by or under this section may, until 1 November 2002, be subject to the Animal Products (Ancillary and Transitional Provisions) Act 1999.

That *Parts 11 to 15 and Schedules 2 to 6* be a separate Bill with the following Title, enacting words, and clause:

**An Act to provide for matters ancillary to the enactment of the Animal Products Act 1999, and in particular to—**

(a) Repeal the Meat Act 1981 on 1 November 2002; and

(b) Amend that Act pending its repeal; and

(c) Make related and consequential amendments to other Acts and regulations; and

- (d) Provide for transitional matters concerning the coming into effect of the Animal Products Act 1999, and particularly its relationship with the Meat Act 1981 over the 3-year period to 1 November 2002

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Animal Products (Ancillary and Transitional Provisions) Act 1999.

(2) This Act comes into force on 1 November 1999, except for sections 202 to 203b.

(3) Sections 202 to 202b come into force on the day on which this Act receives the Royal assent.

EXPLANATORY NOTE

This Supplementary Order Paper splits the Animal Products Bill into 2 separate bills:

- (a) The Animal Products Bill (*Parts 1 to 10 and Schedule 1*); and
- (b) The Animal Products (Ancillary and Transitional Provisions) Bill (*Parts 11 to 15 and Schedules 2 to 6*).
