COMMUNITY MAGISTRATES BILL

Proposed Motion to Divide the Bill into 6 Bills

Rt Hon D A M GRAHAM, in Committee, to move the following motion:

That Part 1 and Schedule 1 be a separate Bill, and that for clause 2 and the heading to Part 1 there be substituted the following Title, enacting words, and clause:

An Act to amend the District Courts Act 1947 for the purpose of providing for the appointment of judicial officers, to be known as Community Magistrates, and of specifying their jurisdiction, functions, and powers

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the District Courts Amendment Act 1998, and is part of the District Courts Act 1947 ("the principal Act").
- (2) This Act comes into force on the date on which this Act receives the Royal assent.

That Part 2 and Schedule 2 be a separate Bill, and that for clause 9 and the heading to Part 2 there be substituted the following Title, enacting words, and clause:

An Act to amend the Summary Proceedings Act 1957
BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Summary Proceedings Amendment Act 1998, and is part of the Summary Proceedings Act 1957 ("the principal Act").
- (2) This Act comes into force on the date on which this Act receives the Royal assent.

That Part 3 be a separate Bill, and that for clause 64 and the heading to Part 3 there be substituted the following Title, enacting words, and clause:

An Act to amend the Criminal Justice Act 1985

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Criminal Justice Amendment Act 1998, and is part of the Criminal Justice Act 1985 ("the principal Act").

(2) This Act comes into force on the date on which this Act

receives the Royal assent.

That *Part 4* be a separate Bill, and that for *clause 70* and the heading to *Part 4* there be substituted the following Title, enacting words, and clause:

An Act to amend the Crimes Act 1961

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Crimes Amendment Act 1998, and is part of the Crimes Act 1961 ("the principal Act").

(2) This Act comes into force on the date on which this Act

receives the Royal assent.

That *Part 5* be a separate Bill, and that for *clause 78* and the heading to *Part 5* there be substituted the following Title, enacting words, and clause:

An Act to amend the Summary Offences Act 1981

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Summary Offences Amendment Act 1998, and is part of the Summary Offences Act 1981 ("the principal Act").

(2) This Act comes into force on the date on which this Act

receives the Royal assent.

That Part 6 be a separate Bill, and that for clause 81 and the heading to Part 6 there be substituted the following Title, enacting words, and clause:

An Act to amend the Oaths and Declarations Act 1957

BE IT ENACTED by the Parliament of New Zealand as follows:

- 1. Short Title and commencement—(1) This Act may be cited as the Oaths and Declarations Amendment Act 1998, and is part of the Oaths and Declarations Act 1957 ("the principal Act").
- (2) This Act comes into force on the date on which this Act receives the Royal assent.
