

FINANCE BILL (NO. 4)

Proposed Amendments

Rt Hon. W. F. BIRCH, in Committee, to move the following amendment:

New Part IA: To insert, after Part I, the following Part:

### PART IA

#### ACCIDENT REHABILITATION AND COMPENSATION INSURANCE CORPORATION

2A. Corporation payment to Crown Bank Account for public health care costs in respect of year ending 30 June 1996—(1) In respect of the year ending with the close of the 30th day of June 1996, the Accident Rehabilitation and Compensation Insurance Corporation shall, not later than that day, pay to a Crown Bank Account nominated by the Minister of Finance the sum of \$123.7 million (inclusive of goods and services tax) in respect of the costs of health and disability services purchased by the regional health authorities in respect of—

(a) Motor vehicle injuries; and

- (b) Work injuries (including subsequent work injuries); and
- (c) Injuries referred to in paragraph (a) or paragraph (b) of this subsection that are suffered by overseas visitors.
- (2) Of the amount specified in subsection (1) of this section-
- (a) Notwithstanding section 100 (3) (a) of the Accident Rehabilitation and Compensation Insurance Act 1992, the Corporation shall debit \$43.647 million (inclusive of goods and services tax) to the Employers' Account established under section 100 of that Act; and
- (b) Notwithstanding section 108 (3) (a) of that Act, the Corporation shall debit \$80.053 million (inclusive of goods and services tax) to the Motor Vehicle Account established under section 108 of that Act—

and section 121 (4) of that Act shall have effect accordingly.

(3) The Corporation is hereby authorised—

- (a) To apply the funds in the said Employers' Account towards payment of the amount referred to in **paragraph** (a) of subsection (2) of this section:
- (b) To apply the funds in the said Motor Vehicle Account towards payment of the amount referred to in **paragraph (b)** of that subsection.

#### EXPLANATORY NOTE

*New Part IA*: The new Part provides for the payment of \$123.7 million by the Accident Rehabilitation and Compensation Insurance Corporation to the Crown.

The payment relates to the year ending 30 June 1996 and represents the costs of health and disability services provided in respect of motor vehicle injuries and work injuries (including subsequent work injuries) that have been purchased by Regional Health Authorities for that year.

The payment comprises \$43.647 million in respect of work injuries and \$80.053 million in respect of motor vehicle injuries.
