INDUSTRIAL LAW REFORM BILL

Proposed Amendments

Hon. Mr BOLGER, in Committee, to move the following amendments:

That *Part I* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Industrial Relations Act 1973

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Industrial Relations Amendment Act 1983, and shall be read together with and deemed part of the Industrial Relations Act 1973 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part II* be a separate Bill, and that for *clause 18* there be substituted the following Title, enacting words, and Short Title:

An Act to promote the employment of persons under the age of 18 years by permitting the payment to such persons of wages at rates lower than adult rates

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Youth Wages Act 1983.

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

That *Part III* and the Schedule be a separate Bill, and that for *clause 25* there be substituted the following Title, enacting words, and Short Title:

An Act to consolidate and amend the law relating to minimum wages

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Minimum Wage Act 1983.

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

That *Part IV* be a separate Bill, and that for *clause 39* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Agricultural Workers Act 1977

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Agricultural Workers Amendment Act (No. 2) 1983, and shall be read together with and deemed part of the Agricultural Workers Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part V* be a separate Bill, and that for *clause 43* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Aircrew Industrial Tribunal Act 1971

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Aircrew Industrial Tribunal Amendment Act 1983, and shall be read together with and deemed part of the Aircrew Industrial Tribunal Act 1971 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part VI* be a separate Bill, and that for *clause 49* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Coal Mines Act 1979

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Coal Mines Amendment Act (No. 2) 1983, and shall be read together with and deemed part of the Coal Mines Act 1979 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part VIA* be a separate Bill, and that for *clause 52A* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Fire Service Act 1975

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Fire Service Amendment Act 1983, and shall be read together with and deemed part of the Fire Service Act 1975 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part VII* be a separate Bill, and that for *clause 53* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the New Zealand Railways Corporation Act 1981

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the New Zealand Railways Corporation Amendment Act 1983, and shall be read together with and deemed part of the New Zealand Railways Corporation Act 1981 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part VIII* be a separate Bill, and that for *clause 57* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Post Office Act 1959

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Post Office Amendment Act 1983, and shall be read together with and deemed part of the Post Office Act 1959 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part IX* be a separate Bill, and that for *clause 60* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the State Services Conditions of Employment Act 1977

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the State Services Conditions of Employment Amendment Act (No. 2) 1983, and shall be read together with and deemed part of the State Services Conditions of Employment Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part X* be a separate Bill, and that for *clause 62* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Technicians Training Act 1967

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Technicians Training Amendment Act 1983, and shall be read together with and deemed part of the Technicians Training Act 1967 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

That *Part XI* be a separate Bill, and that for *clause 64* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Wages Protection Act 1964

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Wages Protection Amendment Act 1983, and shall be read together with and deemed part of the Wages Protection Act 1964 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

That *Part XII* be a separate Bill, and that for *clause 66* there be substituted the following Title, enacting words, and Short Title:

An Act to amend the Waterfront Industry Act 1976

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title and commencement—(1) This Act may be cited as the Waterfront Industry Amendment Act 1983, and shall be read together with and deemed part of the Waterfront Industry Act 1976 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of February 1984.

EXPLANATORY NOTE

This Supplementary Order Paper divides the Industrial Law Reform Bill for the purpose of enabling each Part to be enacted as a separate Act.
