LAW REFORM (MISCELLANEOUS PROVISIONS) BILL (NO. 2)

*Proposed Motion to Divide the Bill into 47 Bills*

Hon. D. A. M. GRAHAM, in Committee, to move the following motion:

That *clauses 2 to 4* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Acts Interpretation Act 1924**

BE IT ENACTED by the Parliament of New Zealand as follows:

LAW LIBRARY

**Short Title and commencement**—(1) This Act may be cited as the Acts Interpretation Amendment Act 1994, and shall be read together with and deemed part of the Acts Interpretation Act 1924 (hereinafter referred to as the principal Act).

(2) Except as provided in **section 4 (2)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 5 to 8* be a separate Bill, and that for *clause 5* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Administration Act 1969**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Administration Amendment Act 1994, and shall be read together with and deemed part of the Administration Act 1969 (hereinafter referred to as the principal Act).

(2) Except as provided in **section 6 (2)** of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 11A to 11C* be a separate Bill, and that for *clause 11A* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Biosecurity Act 1993**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Biosecurity Amendment Act 1994, and shall be read together with and deemed part of the Biosecurity Act 1993 (hereinafter referred to as the principal Act).

That *clause 12* be a separate Bill with the following Title, enacting words, and clause:

**An Act to repeal the Cornish Companies Management Act 1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Cornish Companies Management Act Repeal Act 1994.

That *clauses 13 to 17* be a separate Bill, and that for *clause 13* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Corporations (Investigation and Management) Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Corporations (Investigation and Management) Amendment Act 1994, and shall be read together with and deemed part of the Corporations (Investigation and Management) Act 1989 (hereinafter referred to as the principal Act).

That *clauses 18 to 20* be a separate Bill, and that for *clause 18* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Crimes Act 1961**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Crimes Amendment Act 1994, and shall be read together with and deemed part of the Crimes Act 1961.

That *clauses 21 to 25* be a separate Bill, and that for *clause 21* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Criminal Justice Act 1985**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Criminal Justice Amendment Act 1994, and shall be read together with and deemed part of the Criminal Justice Act 1985 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 1st day of September 1993.

That *clauses 26 to 29* be a separate Bill, and that for *clause 26* there be substituted the following Title, enacting words, and clause:

**An Act to amend the District Courts Act 1947**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the District Courts Amendment Act 1994, and shall be read together with and deemed part of the District Courts Act 1947 (hereinafter referred to as the principal Act).

That *clauses 30 to 32* be a separate Bill, and that for *clause 30* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Domestic Protection Act 1982**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Domestic Protection Amendment Act 1994, and shall be read together with and deemed part of the Domestic Protection Act 1982 (hereinafter referred to as the principal Act).

That *clauses 33 to 70* be a separate Bill, and that for *clause 33* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Evidence Act 1908**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Evidence Amendment Act 1994, and shall be read together with and deemed part of the Evidence Act 1908 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council, and one or more Orders in Council may be made bringing different provisions into force on different dates.

That *clauses 71 to 85* be a separate Bill, and that for *clause 71* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Family Proceedings Act 1980**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Family Proceedings Amendment Act 1994, and shall be read together with and deemed part of the Family Proceedings Act 1980 (hereinafter referred to as the principal Act).

That *clauses 86 to 88A* be a separate Bill, and that for *clause 86* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Forestry Rights Registration Act 1983**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Forestry Rights Registration Amendment Act 1994, and shall be read together with and deemed part of the Forestry Rights Registration Act 1983 (hereinafter referred to as the principal Act).

That *clauses 89 to 91* be a separate Bill, and that for *clause 89* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Forests Act 1949**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Forests Amendment Act 1994, and shall be read together with and deemed part of the Forests Act 1949 (hereinafter referred to as the principal Act).

That *clauses 92 to 103* be a separate Bill, and that for *clause 92* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Gaming and Lotteries Act 1977**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Gaming and Lotteries Amendment Act 1994, and shall be read together with and deemed part of the Gaming and Lotteries Act 1977 (hereinafter referred to as the principal Act).

That *clauses 104 to 107* be a separate Bill, and that for *clause 104* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Guardianship Act 1968**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Guardianship Amendment Act 1994, and shall be read together with and deemed part of the Guardianship Act 1968 (hereinafter referred to as the principal Act).

That *clauses 108 and 109* be a separate Bill, and that for *clause 108* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Harbours Act 1950**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Harbours Amendment Act 1994, and shall be read together with and deemed part of the Harbours Act 1950 (hereinafter referred to as the principal Act).

That *clauses 109A to 109c* be a separate Bill, and that for *clause 109A* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Health Act 1956**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Health Amendment Act 1994, and shall be read together with and deemed part of the Health Act 1956 (hereinafter referred to as the principal Act).

That *clauses 110 to 123* be a separate Bill, and that for *clause 110* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Hotel Association of New Zealand Act 1969**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Hotel Association of New Zealand Amendment Act 1994, and shall be read together with and deemed part of the Hotel Association of New Zealand Act 1969 (hereinafter referred to as the principal Act).

That *clauses 124 to 126* be a separate Bill, and that for *clause 124* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Industrial and Provident Societies Act 1908**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Industrial and Provident Societies Amendment Act 1994, and shall be read together with and deemed part of the Industrial and Provident Societies Act 1908 (hereinafter referred to as the principal Act).

That *clauses 127 to 130* be a separate Bill, and that for *clause 127* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Insolvency Act 1967**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Insolvency Amendment Act 1994, and shall be read together with and deemed part of the Insolvency Act 1967 (hereinafter referred to as the principal Act).

That *clauses 131 to 149* be a separate Bill with the following Title, enacting words, and clause:

**An Act to effect certain reforms in the law governing insurance intermediaries**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Insurance Intermediaries Act 1994.

That *clauses 150 to 152* be a separate Bill, and that for *clause 150* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Judicature Act 1908**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Judicature Amendment Act 1994, and shall be read together with and deemed part of the Judicature Act 1908 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1994.

That *clauses 153 and 154* be a separate Bill, and that for *clause 153* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Land Transfer Act 1952**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Land Transfer Amendment Act 1994, and shall be read together with and deemed part of the Land Transfer Act 1952 (hereinafter referred to as the principal Act).

That *clauses 155 to 161* be a separate Bill, and that for *clause 155* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Law Practitioners Act 1982**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Law Practitioners Amendment Act 1994, and shall be read together with and deemed part of the Law Practitioners Act 1982 (hereinafter referred to as the principal Act).

That *clauses 162 to 166A* be a separate Bill, and that for *clause 162* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Local Government Act 1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Local Government Amendment Act 1994, and shall be read together with and deemed part of the Local

Government Act 1974 (hereinafter referred to as the principal Act).

(2) Except as provided in section 165, (3) of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 167 to 171* be a separate Bill, and that for *clause 167* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Matrimonial Property Act 1976**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Matrimonial Property Amendment Act 1994, and shall be read together with and deemed part of the Matrimonial Property Act 1976 (hereinafter referred to as the principal Act).

That *clauses 172 to 183* be a separate Bill, and that for *clause 172* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Motor Vehicle Dealers Act 1975**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Motor Vehicle Dealers Amendment Act 1994, and shall be read together with and deemed part of the Motor Vehicle Dealers Act 1975 (hereinafter referred to as the principal Act).

(2) Except as provided in section 175 (4) of this Act, this Act shall come into force on the day on which it receives the Royal assent.

That *clauses 184 to 188* be a separate Bill, and that for *clause 184* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Motor Vehicle Securities Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Motor Vehicle Securities Amendment Act 1994, and shall be read together with and deemed part of the Motor Vehicle Securities Act 1989 (hereinafter referred to as the principal Act).

(2) Except as provided in subsection (3) of this section, this Act shall come into force on the day on which it receives the Royal assent.

(3) Sections 186 to 188 of this Act shall be deemed to have come into force on the 21st day of September 1993.

That *clauses 189 and 190* be a separate Bill, and that for *clause 189* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Mutual Assistance in Criminal Matters Act 1992**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Mutual Assistance in Criminal Matters Amendment Act 1994, and shall be read together with and deemed part of the Mutual Assistance in Criminal Matters Act 1992.

That *clauses 191 to 193* be a separate Bill, and that for *clause 191* there be substituted the following Title, enacting words, and clause:

**An Act to amend the New Zealand Film Commission Act 1978**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the New Zealand Film Commission Amendment Act 1994, and shall be read together with and deemed part of the New Zealand Film Commission Act 1978 (hereinafter referred to as the principal Act).

That *clauses 194 to 196* be a separate Bill, and that for *clause 194* there be substituted the following Title, enacting words, and clause:

**An Act to amend the New Zealand Symphony Orchestra Act 1988**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the New Zealand Symphony Orchestra Amendment Act 1994, and shall be read together with and deemed part of the New Zealand Symphony Orchestra Act 1988 (hereinafter referred to as the principal Act).

That *clauses 197 to 201* be a separate Bill, and that for *clause 197* there be substituted the following Title, enacting words, and clause:

**An Act to amend the New Zealand Trade Development Board Act 1988**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the New Zealand Trade Development Board Amendment Act 1994, and shall be read together with and deemed part of the New Zealand Trade Development Board Act 1988 (hereinafter referred to as the principal Act).

That *clauses 202 and 203* be a separate Bill, and that for *clause 202* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Plant Variety Rights Act 1987**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Plant Variety Rights Amendment Act 1994, and shall be read together with and deemed part of the Plant Variety Rights Act 1987 (hereinafter referred to as the principal Act).

That *clauses 204 to 206* be a separate Bill, and that for *clause 204* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Police Complaints Authority Act 1988**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Police Complaints Authority Amendment Act 1994, and shall be read together with and deemed part of the Police Complaints Authority Act 1988 (hereinafter referred to as the principal Act).

That *clauses 207 to 217* be a separate Bill, and that for *clause 207* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Protection of Personal and Property Rights Act 1988**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Protection of Personal and Property Rights Amendment Act 1994, and shall be read together with and deemed part of the Protection of Personal and Property Rights Act 1988 (hereinafter referred to as the principal Act).

That *clause 218* be a separate Bill with the following Title, enacting words, and clause:

**An Act to repeal the Public Contracts Act 1908**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Public Contracts Act Repeal Act 1994.

That *clauses 219 to 221* be a separate Bill, and that for *clause 219* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Public Trust Office Act 1957**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Public Trust Office Amendment Act 1994, and shall be read together with and deemed part of the Public Trust Office Act 1957 (hereinafter referred to as the principal Act).

That *clauses 222 and 223* be a separate Bill, and that for *clause 222* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Radiocommunications Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Radiocommunications Amendment Act 1994, and shall be read together with and deemed part of the Radiocommunications Act 1989 (hereinafter referred to as the principal Act).

That *clauses 224 to 226* be a separate Bill, and that for *clause 224* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Rates Rebate Act 1973**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Rates Rebate Amendment Act 1994, and shall be read together with and deemed part of the Rates Rebate Act 1973 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1994.

That *clauses 227 to 229* be a separate Bill, and that for *clause 227* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Real Estate Agents Act 1976**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Real Estate Agents Amendment Act 1994, and shall be read together with and deemed part of the Real Estate Agents Act 1976 (hereinafter referred to as the principal Act).



That *clauses 230 to 235* and the Schedule be a separate Bill, and that for *clause 230* there be substituted the following Title, enacting words, and clause:

**An Act to give effect to the provisions of the United Nations Convention on Contracts for the International Sale of Goods**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Sale of Goods (United Nations Convention) Act 1994.

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council.

That *clauses 236 to 238* be a separate Bill, and that for *clause 236* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Sale of Liquor Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Sale of Liquor Amendment Act 1994, and shall be read together with and deemed part of the Sale of Liquor Act 1989 (hereinafter referred to as the principal Act).

That *clauses 239 to 241* be a separate Bill, and that for *clause 239* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Sharebrokers Act 1908**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Sharebrokers Amendment Act 1994, and shall be read together with and deemed part of the Sharebrokers Act 1908 (hereinafter referred to as the principal Act).

That *clauses 242 and 243* be a separate Bill, and that for *clause 242* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Telecommunications Act 1987**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Telecommunications Amendment Act 1994, and shall be read together with and deemed part of the Telecommunications Act 1987 (hereinafter referred to as the principal Act).

That *clauses 244 to 246* be a separate Bill, and that for *clause 244* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Valuation of Land Act 1951**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Valuation of Land Amendment Act 1994, and shall be read together with and deemed part of the Valuation of Land Act 1951 (hereinafter referred to as the principal Act).

That *clauses 247 to 250* be a separate Bill, and that for *clause 247* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Valuers Act 1948**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Valuers Amendment Act 1994, and shall be read together with and deemed part of the Valuers Act 1948 (hereinafter referred to as the principal Act).

That *clauses 251* and *252* be a separate Bill, and that for *clause 251* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Victims of Offences Act 1987**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title**—This Act may be cited as the Victims of Offences Amendment Act 1994, and shall be read together with and deemed part of the Victims of Offences Act 1987 (hereinafter referred to as the principal Act).
