LAND TRANSPORT LAW REFORM BILL

*Proposed Motion to Divide the Bill into 7 Bills*

Hon. MAURICE WILLIAMSON, in Committee, to move as follows:

That *clause 1, Part I, and the Schedules* be a separate Bill, and that for *clauses 1 and 2*, and the headings above *clause 2*, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transit New Zealand Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Transit New Zealand Amendment Act 1995, and shall be read together with and deemed part of the Transit New Zealand Act 1989 (hereinafter referred to as the principal Act).

(2) Except as provided in subsection (3) of this section, this Act shall come into force on the day on which it receives the Royal assent.

(3) Sections 8 to 36 (except section 33(1)) of this Act, and the Schedules to this Act, shall come into force on the 1st day of July 1996.

That *Part II* be a separate Bill, and that for *clause 37*, and the headings above that clause, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Land Transport Act 1993**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Land Transport Amendment Act 1995, and shall be read together with and deemed part of the Land Transport Act 1993 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of July 1996.

That *Part III* be a separate Bill, and that for *clause 43*, and the headings above that clause, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport Act 1962**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Transport Amendment Act 1995, and shall be read together with and deemed part of the Transport Act 1962 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *Part IV* be a separate Bill, and that for *clause 54*, and the headings above that clause, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport (Vehicle and Driver Registration and Licensing) Act 1986**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Transport (Vehicle and Driver Registration and Licensing) Amendment Act 1995, and shall be read together with and deemed part of the Transport (Vehicle and Driver Registration and Licensing) Act 1986 (hereinafter referred to as the principal Act).

(2) Sections 55, 59, and 59A of this Act shall come into force on the day on which this Act receives the Royal assent.

(3) Except as provided in subsection (2) of this section, this Act shall come into force on a date to be appointed by the Governor-General by Order in Council; and one or more Orders in Council may be made bringing different provisions into force on different dates.

That *Part V* be a separate Bill, and that for *clause 60*, and the headings above that clause, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Local Government Act 1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Local Government Amendment Act (No. 3) 1995, and shall be read together with and deemed part of the Local Government Act 1974 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *Part VI* be a separate Bill, and that for *clause 62*, and the headings above that clause, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Road User Charges Act 1977**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Road User Charges Amendment Act 1995, and shall be read together with and deemed part of the Road User Charges Act 1977 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.

That *Part VII* be a separate Bill, and that for *clause 65*, and the headings above that clause, there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport Services Licensing Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Transport Services Licensing Amendment Act 1995, and shall be read together with and deemed part of the Transport Services Licensing Act 1989 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the day on which it receives the Royal assent.
