MINISTERS' SALARIES AND ALLOWANCES BILL.

Mr. BARRON, in Committee, to move:-

In clause 3, to strike out the words "eight hundred," in the fourth line; to substitute the word "five" for the word "six," in the last line but three; to substitute the numerals "£4,000" for "£4,800," in the last line.

In clause 4, to substitute the word "four" for the word "five,"

in the last line.

LAND ACT AMENDMENT BILL.

Mr. Kerr, in Committee, to move the following new section:—

Clause 3 of Appendix C and clause 4 of Appendix D to the said Act are hereby repealed, and the following substituted in each Appendix: The upset price of rural land shall be from five shillings to forty shillings per acre, as may be fixed by the Commissioner.

Mr. VALENTINE, in Committee, to move:

Clause 14. After the word "land," in line 45, to add, "The priority of right to occupy or acquire the land shall be determined by lot in manner to be prescribed by regulation in that behalf."

Subsections (1) and (2) to be struck out.

PARLIAMENTARY HONORARIUM AND PRIVILEGES ACT 1884 AMENDMENT BILL.

Dr. Hodgkinson, in Committee, to move:-

In clause 2, subsection (2), after the word "session" to strike out the words "one hundred pounds," and to insert the words "the sum of ten pounds per week for the first eight weeks of the session, five pounds per week for the next four weeks, together."

HOSPITALS AND CHARITABLE INSTITUTIONS ACT 1885 AMENDMENT BILL.

Mr. Beetham, in Committee, to move the following new section:—

Wairarapa District separated from Wellington.hereby repealed, and the Wellington and Wairarapa Districts are hereby severally constituted hospital districts under the said Act, as

if they had never formed part of any united district.

The Board of the united districts of Wairarapa with the Wellington District is hereby dissolved; and all the assets and liabilities of such united district at the time of its dissolution shall be apportioned among the Boards of the two districts hitherto forming part of such united district in such proportions as shall be allocated by such person or persons as may be appointed by the Governor in that behalf.

This section shall not come into force before the first day of

April next after the passing thereof.

Mr. Bruce, in Committee, to move the following new section:—

Notwithstanding anything contained in section five of this Act, whenever an Order in Council shall be issued constituting the new Hospital District of Manawatu, as defined in section two, all endowments originally set apart for the Wanganui Hospital shall be retained and belong wholly to the Hospital District of Wanganui, and shall be subject to the sole control and management of the Board of the said Wanganui Hospital District.
