MAORI TRUST BOARDS AMENDMENT BILL  
*Proposed Motion to Divide the Bill into 7 Bills*

Hon. K. T. WETERE, in Committee, to move as follows:

That *Part I* (comprising *clauses 8 to 18*) be a separate Bill with the following Title, enacting words, and Short Title:**An Act to establish Te Runanga o Ngati Awa as a Maori Trust Board**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Te Runanga o Ngati Awa Act 1988.

(2) This Act shall come into force on the 28th day after the date on which it receives the Royal assent.

That *Part II* (comprising *clauses 19 to 23*) be a separate Bill with the following Title, enacting words, and Short Title:**An Act to establish the Hauraki Maori Trust Board**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Hauraki Maori Trust Board Act 1988.

(2) This Act shall come into force on the 28th day after the date on which it receives the Royal assent.

That *Part III* (comprising *clauses 24 to 31*) be a separate Bill with the following Title, enacting words, and Short Title:**An Act to establish the Maniapoto Maori Trust Board**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Maniapoto Maori Trust Board Act 1988.

(2) This Act shall come into force on the 28th day after the date on which it receives the Royal assent.

That *Part IV* (comprising *clauses 32 to 37*) be a separate Bill with the following Title, enacting words, and Short Title:**An Act to establish the Whanganui Maori Trust Board**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Whanganui River Trust Board Act 1988.

(2) This Act shall come into force on the 28th day after the date on which it receives the Royal assent.

That *Part V* (comprising *clauses 38 to 45*) be a separate Bill with the following Title, enacting words, and Short Title:

**An Act to establish Te Runanga o Ngati Whatua as a  
Maori Trust Board**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Te Runanga o Ngati Whatua Act 1988.

(2) This Act shall come into force on the 28th day after the date on which it receives the Royal assent.

That *Part VI* (comprising *clauses 46 and 47*) be a separate Bill, and that for *clause 46* there be substituted the following Title, enacting words, and Short Title:

**An Act to amend the Tauranga-Moana Maori Trust  
Board Act 1981**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Tauranga-Moana Maori Trust Board Amendment Act 1988, and shall be read together with and deemed part of the Tauranga-Moana Maori Trust Board Act 1981 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 28th day after the date on which it receives the Royal assent.
