STATUTES AMENDMENT BILL

Proposed Motion to Divide Bill into 49 Bills

Right Hon. GEOFFREY PALMER, in Committee, to move as follows:

That *clauses 2 to 4* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

An Act to amend the Agricultural Pests Destruction Act 1967

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Agricultural Pests Destruction Amendment Act 1988, and shall be read together with and deemed part of the Agricultural Pests Destruction Act 1967 (hereinafter referred to as the principal Act).

That *clauses 5 to 7* be a separate Bill, and that for *clause 5* there be substituted the following Title, enacting words, and clause:

An Act to amend the Armed Forces Canteens Act 1948

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Armed Forces Canteens Amendment Act 1988, and shall be read together with and deemed part of the Armed Forces Canteens Act 1948 (hereinafter referred to as the principal Act).

That *clauses 8 to 10* be a separate Bill, and that for *clause 8* there be substituted the following Title, enacting words, and clause:

An Act to amend the Armed Forces Discipline Act 1971

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Armed Forces Discipline Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Armed Forces Discipline Act 1971 (hereinafter referred to as the principal Act).

That *clauses 11 to 13* be a separate Bill, and that for *clause 11* there be substituted the following Title, enacting words, and clause:

An Act to amend the Boilers, Lifts, and Cranes Act 1950

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Boilers, Lifts, and Cranes Amendment Act 1988, and shall be read together with and deemed part of the Boilers, Lifts, and Cranes Act 1950 (hereinafter referred to as the principal Act).

That *clauses 14 to 16* be a separate Bill, and that for *clause 14* there be substituted the following Title, enacting words, and clause:

An Act to amend the Carter Observatory Act 1938

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Carter Observatory Amendment Act 1988, and shall be read together with and deemed part of the Carter Observatory Act 1938 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of April 1989.

That *clauses 17 to 19* be a separate Bill, and that for *clause 17* there be substituted the following Title, enacting words, and clause:

An Act to amend the Children's Health Camps Act 1972

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Children's Health Camps Amendment Act 1988, and shall be read together with and deemed part of the Children's Health Camps Act 1972 (hereinafter referred to as the principal Act).

That *clauses 20 and 21* be a separate Bill, and that for *clause 20* there be substituted the following Title, enacting words, and clause:

An Act to amend the Clean Air Act 1972

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Clean Air Amendment Act 1988, and shall be read together with and deemed part of the Clean Air Act 1972 (hereinafter referred to as the principal Act).

That *clauses 22 and 23* be a separate Bill, and that for *clause 22* there be substituted the following Title, enacting words, and clause:

An Act to amend the Criminal Justice Act 1985

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Criminal Justice Amendment Act 1988, and shall be read together with and deemed part of the Criminal Justice Act 1985 (hereinafter referred to as the principal Act).

That *clauses 24 and 25* be a separate Bill, and that for *clause 24* there be substituted the following Title, enacting words, and clause:

An Act to amend the Customs Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Customs Amendment Act (No. 3) 1988, and shall be read together with and deemed part of the Customs Act 1966 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 1st day of December 1988.

That *clauses 26 and 27* be a separate Bill, and that for *clause 26* there be substituted the following Title, enacting words, and clause:

An Act to amend the District Courts Act 1947

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the District Courts Amendment Act 1988, and shall be read together with and deemed part of the District Courts Act 1947 (hereinafter referred to as the principal Act).

That *clauses 28 to 30* be a separate Bill, and that for *clause 28* there be substituted the following Title, enacting words, and clause:

An Act to amend the Dog Control and Hydatids Act 1982

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Dog Control and Hydatids Amendment Act 1988, and shall be read together with and deemed part of the Dog Control and Hydatids Act 1982 (hereinafter referred to as the principal Act).

That *clauses 31 and 32* be a separate Bill, and that for *clause 31* there be substituted the following Title, enacting words, and clause:

An Act to amend the Family Proceedings Act 1980

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Family Proceedings Amendment Act 1988, and shall be read together with and deemed part of the Family Proceedings Act 1980 (hereinafter referred to as the principal Act).

That *clauses 36 to 38* be a separate Bill, and that for *clause 36* there be substituted the following Title, enacting words, and clause:

An Act to amend the Gaming and Lotteries Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Gaming and Lotteries Amendment Act 1988, and shall be read together with and deemed part of the Gaming and Lotteries Act 1977 (hereinafter referred to as the principal Act).

That *clauses 39 and 40* be a separate Bill, and that for *clause 39* there be substituted the following Title, enacting words, and clause:

An Act to amend the Guardianship Act 1968

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Guardianship Amendment Act 1988, and shall be read together with and deemed part of the Guardianship Act 1968 (hereinafter referred to as the principal Act).

That *clauses 41 and 42* be a separate Bill, and that for *clause 41* there be substituted the following Title, enacting words, and clause:

An Act to amend the Harbours Act 1950

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Harbours Amendment Act (No. 5) 1988, and shall be read together with and deemed part of the Harbours Act 1950 (hereinafter referred to as the principal Act).

That *clauses 43 and 44* be a separate Bill, and that for *clause 43* there be substituted the following Title, enacting words, and clause:

An Act to amend the Historic Places Act 1980

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Historic Places Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Historic Places Act 1980 (hereinafter referred to as the principal Act).

That *clauses 45 and 46* be a separate Bill, and that for *clause 45* there be substituted the following Title, enacting words, and clause:

An Act to amend the Howard Estate Act 1978

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Howard Estate Amendment Act 1988, and shall be read together with and deemed part of the Howard Estate Act 1978 (hereinafter referred to as the principal Act).

That *clauses 47 and 49* be a separate Bill, and that for *clause 47* there be substituted the following Title, enacting words, and clause:

An Act to amend the Immigration Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Immigration Amendment Act 1988, and shall be read together with and deemed part of the Immigration Act 1987 (hereinafter referred to as the principal Act).

That *clauses 50 to 52* be a separate Bill, and that for *clause 50* there be substituted the following Title, enacting words, and clause:

An Act to amend the Invercargill Licensing Trust Act 1950

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Invercargill Licensing Trust Amendment Act 1988, and shall be read together with and deemed part of the Invercargill Licensing Trust Act 1950 (hereinafter referred to as the principal Act).

That *clauses 53 and 54* be a separate Bill, and that for *clause 53* there be substituted the following Title, enacting words, and clause:

An Act to amend the Joint Council for Local Authorities Services Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Joint Council for Local Authorities Services Amendment Act 1988, and shall be read together with and deemed part of the Joint Council for Local Authorities Services Act 1977 (hereinafter referred to as the principal Act).

That *clauses 55 to 57* be a separate Bill, and that for *clause 55* there be substituted the following Title, enacting words, and clause:

An Act to amend the Judicature Act 1908

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Judicature Amendment Act (No. 2) 1988, and shall be read together with

and deemed part of the Judicature Act 1908 (hereinafter referred to as the principal Act).

That *clauses 58 to 60* be a separate Bill, and that for *clause 58* there be substituted the following Title, enacting words, and clause:

An Act to amend the Lake Wanaka Preservation Act 1973

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Lake Wanaka Preservation Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Lake Wanaka Preservation Act 1973 (hereinafter referred to as the principal Act).

That *clauses 61 to 63* be a separate Bill, and that for *clause 61* there be substituted the following Title, enacting words, and clause:

An Act to amend the Licensing Trusts Act 1949

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Licensing Trusts Amendment Act 1988, and shall be read together with and deemed part of the Licensing Trusts Act 1949 (hereinafter referred to as the principal Act).

That *clauses 64 and 65* be a separate Bill, and that for *clause 64* there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Authorities (Members' Interests) Act 1968

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Local Authorities (Members' Interests) Amendment Act 1988, and shall be read together with and deemed part of the Local Authorities (Members' Interests) Act 1968 (hereinafter referred to as the principal Act).

That *clauses 66 and 67* be a separate Bill, and that for *clause 66* there be substituted the following Title, enacting words, and clause:

An Act to amend the Local Government Official Information and Meetings Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Local Government Official Information and Meetings Amendment Act 1988, and shall be read together with and deemed part of the Local Government Official Information and Meetings Act 1987 (hereinafter referred to as the principal Act).

That *clauses 68 to 70* be a separate Bill, and that for *clause 68* there be substituted the following Title, enacting words, and clause:

An Act to amend the Masterton Licensing Trust Act 1947

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Masterton Licensing Trust Amendment Act 1988, and shall be read together with and deemed part of the Masterton Licensing Trust Act 1947 (hereinafter referred to as the principal Act).

That *clauses 71 and 72* be a separate Bill, and that for *clause 71* there be substituted the following Title, enacting words, and clause:

An Act to amend the Medical and Dental Auxiliaries Act 1966

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Medical and Dental Auxiliaries Amendment Act 1988, and shall be read together with and deemed part of the Medical and Dental Auxiliaries Act 1966 (hereinafter referred to as the principal Act).

That *clauses 73 to 75* be a separate Bill, and that for *clause 73* there be substituted the following Title, enacting words, and clause:

An Act to amend the National Roads Act 1953

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the National Roads Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the National Roads Act 1953 (hereinafter referred to as the principal Act).

(2) This Act shall be deemed to have come into force on the 1st day of April 1988.

That *clauses 76 and 77* be a separate Bill, and that for *clause 76* there be substituted the following Title, enacting words, and clause:

An Act to amend the New Zealand Geographic Board Act 1946

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Geographic Board Amendment Act 1988, and shall be read together with and deemed part of the New Zealand Geographic Board Act 1946 (hereinafter referred to as the principal Act).

That *clauses 78 to 80* be a separate Bill, and that for *clause 78* there be substituted the following Title, enacting words, and clause:

An Act to amend the New Zealand Walkways Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the New Zealand Walkways Amendment Act 1988, and shall be read together with and deemed part of the New Zealand Walkways Act 1975 (hereinafter referred to as the principal Act).

That *clauses 81 to 83* be a separate Bill, and that for *clause 81* there be substituted the following Title, enacting words, and clause:

An Act to amend the Noxious Plants Act 1978

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Noxious Plants Amendment Act 1988, and shall be read together with and deemed part of the Noxious Plants Act 1978 (hereinafter referred to as the principal Act).

That *clauses 84 and 85* be a separate Bill, and that for *clause 84* there be substituted the following Title, enacting words, and clause:

An Act to amend the Ombudsmen Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Ombudsmen Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Ombudsmen Act 1975 (hereinafter referred to as the principal Act).

That *clauses 86 and 87* be a separate Bill, and that for *clause 86* there be substituted the following Title, enacting words, and clause:

An Act to amend the Plumbers, Gasfitters, and Drainlayers Act 1976

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Plumbers, Gasfitters, and Drainlayers Amendment Act 1988, and shall be read together with and deemed part of the Plumbers, Gasfitters, and Drainlayers Act 1976 (hereinafter referred to as the principal Act).

That *clauses 88 and 89* be a separate Bill, and that for *clause 88* there be substituted the following Title, enacting words, and clause:

An Act to amend the Police Complaints Authority Act 1988

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title and commencement—(1) This Act may be cited as the Police Complaints Authority Amendment Act 1988, and shall be read together with and deemed part of the Police Complaints Authority Act 1988 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the date of commencement of the principal Act.

That *clauses 90 to 92* be a separate Bill, and that for *clause 90* there be substituted the following Title, enacting words, and clause:

An Act to amend the Queen Elizabeth the Second National Trust Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Queen Elizabeth the Second National Trust Amendment Act 1988, and shall be read together with and deemed part of the Queen Elizabeth the Second National Trust Act 1977 (hereinafter referred to as the principal Act).

That *clauses 93 and 94* be a separate Bill, and that for *clause 93* there be substituted the following Title, enacting words, and clause:

An Act to amend the Queen Elizabeth the Second Technicians' Study Award Act 1970

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Queen Elizabeth the Second Technicians' Study Award Amendment Act 1988, and shall be read together with and deemed part of the Queen Elizabeth the Second Technicians' Study Award Act 1970 (hereinafter referred to as the principal Act).

That *clauses 95 and 97* be a separate Bill, and that for *clause 95* there be substituted the following Title, enacting words, and clause:

An Act to amend the Racing Act 1971

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Racing Amendment Act 1988, and shall be read together with and deemed part of the Racing Act 1971 (hereinafter referred to as the principal Act).

An Act to amend the Soil Conservation and Rivers Control Act 1941

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Soil Conservation and Rivers Control Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Soil Conservation and Rivers Control Act 1941 (hereinafter referred to as the principal Act).

That *clauses 103 and 104* be a separate Bill, and that for *clause 103* there be substituted the following Title, enacting words, and clause:

An Act to amend the Statistics Act 1975

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Statistics Amendment Act 1988, and shall be read together with and deemed part of the Statistics Act 1975 (hereinafter referred to as the principal Act).

That *clauses 105 and 106* be a separate Bill, and that for *clause 105* there be substituted the following Title, enacting words, and clause:

An Act to amend the Town and Country Planning Act 1977

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Town and Country Planning Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Town and Country Planning Act 1977 (hereinafter referred to as the principal Act).

That *clauses 107 and 108* be a separate Bill, and that for *clause 107* there be substituted the following Title, enacting words, and clause:

An Act to amend the Toxic Substances Act 1979

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Toxic Substances Amendment Act 1988, and shall be read together

with and deemed part of the Toxic Substances Act 1979 (hereinafter referred to as the principal Act).

That *clauses 109 and 110* be a separate Bill, and that for *clause 109* there be substituted the following Title, enacting words, and clause:

An Act to amend the Trustee Act 1956

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Trustee Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Trustee Act 1956 (hereinafter referred to as the principal Act).

That *clauses 111 to 113* be a separate Bill, and that for *clause 111* there be substituted the following Title, enacting words, and clause:

An Act to amend the Urban Transport Act 1980

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Urban Transport Amendment Act 1988, and shall be read together with and deemed part of the Urban Transport Act 1980 (hereinafter referred to as the principal Act).

That *clauses 114 and 115* be a separate Bill, and that for *clause 114* there be substituted the following Title, enacting words, and clause:

An Act to amend the Valuation of Land Act 1951

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Valuation of Land Amendment Act (No. 2) 1988, and shall be read together with and deemed part of the Valuation of Land Act 1951 (hereinafter referred to as the principal Act).

That *clauses 116 and 117* be a separate Bill, and that for *clause 116* there be substituted the following Title, enacting words, and clause:

An Act to amend the Victims of Offences Act 1987

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Victims of Offences Amendment Act 1988, and shall be read together with and deemed part of the Victims of Offences Act 1987 (hereinafter referred to as the principal Act).

That *clauses 118 and 119* be a separate Bill, and that for *clause 118* there be substituted the following Title, enacting words, and clause:

An Act to amend the Winston Churchill Memorial Trust Act 1965

BE IT ENACTED by the Parliament of New Zealand as follows:

1. Short Title—This Act may be cited as the Winston Churchill Memorial Trust Amendment Act 1988, and shall be read together with and deemed part of the Winston Churchill Memorial Trust Act 1965 (hereinafter referred to as the principal Act).

That *clauses 120 and 121* be a separate Bill, and that for *clause 120* there be substituted the following Title, enacting words, and clause:

An Act to amend the Pork Industry Board Act 1982
