## Supplementary Order Paper

### Taxation (Annual Rates, Maori Organisations, Taxpayer Compliance and Miscellaneous Provisions) Bill

*Proposed motion to divide Bill into 4 Bills*

Hon Dr Michael Cullen, in Committee, to move the following motion:

That the *enacting words and clauses 1 and 2, and Parts 2 to 4, other than clauses 145 to 158 and the heading before clause 145*, be a separate Bill, and that for the *enacting words and clauses 1 and 2* there be substituted the following enacting words, title clause and commencement clause:

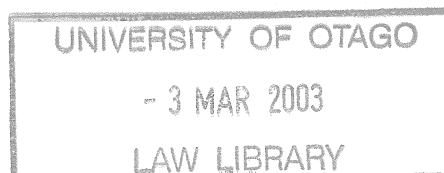
**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Taxation (Maori Organisations, Taxpayer Compliance and Miscellaneous Provisions) Act **2003**.

**2 Commencement**

- (1) This Act comes into force on the day on which it receives the Royal assent, except as provided in this section.
- (2) **Sections 5B and 65(14B)** are treated as coming into force on 28 May 2002.
- (3) **Section 45** comes into force on 15 January 2004.
- (4) **Sections 58B and 165 to 171** are treated as coming into force on 17 October 2002.
- (5) **Sections 37, 59(1A), 65(6B), 72(5), 81, 95(1) to (3), 97, 99(2), 100, 101, 102(2), 103, 104, 124(1), 127C, and 130** come into force on 1 April 2003.
- (6) **Sections 133 to 136, 137(2), and 138 to 142** come into force on 1 July 2003.



That *Part 1* be a separate Bill, and that for the heading to *Part 1* there be substituted the following enacting words, title clause and commencement clause:

**The Parliament of New Zealand enacts as follows:**

- 1 Title**  
This Act is the Taxation (Annual Rates of Income Tax 2002–03) Act **2003**.
- 2 Commencement**  
This Act comes into force on the day on which it receives the Royal assent.

That the *heading before clause 145* and *clauses 145 to 154* be a separate Bill, and that for the *heading before clause 145* there be substituted the following enacting words, title clause and commencement clause:

**The Parliament of New Zealand enacts as follows:**

- 1 Title**  
This Act is the Student Loan Scheme Amendment Act **2003**.
- 2 Commencement**  
This Act comes into force on the day on which it receives the Royal assent.

That the *heading before clause 155* and *clauses 155 to 158* be a separate Bill, and that for the *heading before clause 155* there be substituted the following enacting words, title clause and commencement clause:

**The Parliament of New Zealand enacts as follows:**

- 1 Title**  
This Act is the Child Support Amendment Act **2003**.
- 2 Commencement**  
This Act comes into force on the day on which it receives the Royal assent.
