Taxation (Annual Rates, GST, Trans-Tasman Imputation and Miscellaneous Provisions) Bill

Proposed motion to divide Bill into 4 Bills

Hon Dr Michael Cullen, in Committee, to move:

That *the enacting words and clauses 1 and 2, and Parts 2 to 4, other than the heading before clause 125 and clauses 125 to 131 and the heading before clause 134 and clause 134*, be a separate Bill, and that for *the enacting words and clauses 1 and 2* there be substituted the following enacting words and clauses:

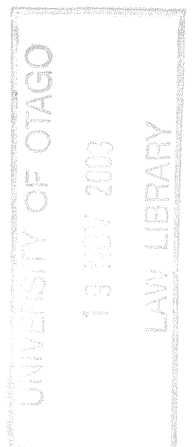
The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Taxation (GST, Trans-Tasman Imputation and Miscellaneous Provisions) Act **2003**.

2 Commencement

- (1) This Act comes into force on the date on which it receives the Royal assent, except as provided in this section.
- (2) **Section 103** is treated as coming into force on 1 July 1994.
- (3) **Sections 51(2) and 53(2)** are treated as coming into force on 20 December 1994.
- (4) **Section 75** is treated as coming into force on 1 April 1995.
- (5) **Sections 52(1) and 54(1)** are treated as coming into force on 26 July 1996.
- (6) **Section 90** is treated as coming into force on 1 October 1996.
- (8) **Sections 43(1), 95 and 99** are treated as coming into force on April 1998.
- (8B) **Section 13B(a)** is treated as coming into force on 1 July 1999.



- (8C) **Section 13B(b)** is treated as coming into force on 1 April 2002.
- (9) **Sections 87 and 88** are treated as coming into force on 17 October 2002.
- (10) **Sections 19, 66(16), 66(28B), 78(1) to (3), 94B, 94C, 97, 97B and 135** are treated as coming into force on 26 March 2003.
- (11) **Sections 15, 32 to 34, 37 to 39(1), 41, 42, 43(2), 44 to 50G, 56, 60, 64, 66(1), 66(2), 66(6), 66(7), 66(10) to (13), 66(23), 66(25), 66(27), 66(29), 67, 70(1), 77, 80 to 82, 83, 93 and 96** are treated as coming into force on 1 April 2003.
- (11B) **Sections 106(5), 106(6) and 110(2)** are treated as coming into force on 1 July 2003.
- (11C) **Section 137(2) to (4)** are treated as coming into force on 1 August 2003.
- (13) **Sections 39(2) and 60B** are treated as coming into force on 1 October 2003.
- (13B) **Section 137(1)** comes into force on the 1st day of the month that immediately follows the month in which this Act receives the Royal assent.
- (13C) **Sections 54G to 54N** come into force on 15 January 2004.
- (14) **Sections 55(2), 57 to 59, 71(3) and 71(4)** come into force on 1 April 2004.
- (15) **Sections 101(2), 102, 104(2), 105, 106(2), 106(3), 107, 108, 109(2), 109(3), 109(5), 113(1), 114, 115, 116(1), 117, 118, 122(1) to (1C), 122(4) and 123** come into force on a date that is the first day of a January, April, July or October and is not less than 1 year after the date on which this Act receives the Royal assent and is to be appointed by the Governor-General by Order in Council.

That *Part 1* be a separate Bill, and that for the *heading to Part 1* there be substituted the following enacting words, Title clause and Commencement clause:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Taxation (Annual Rates of Income Tax 2003–04) Act **2003**.

2 Commencement

This Act comes into force on the day on which it receives the Royal assent.

That the *heading before clause 125* and *clauses 125 to 131* be a separate Bill, and that for the *heading before clause 125* there be substituted the following enacting words, Title clause and Commencement clause:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Student Loan Scheme Amendment Act (No 2) **2003**.

2 Commencement

- (1) This Act comes into force on the day on which it receives the Royal assent, except as provided in this section.
- (1B) **Section 130(1) and (3)** are treated as coming into force on 1 April 1997.
- (2) **Section 130(2B)** is treated as coming into force on 26 March 2003.

That the *heading before clause 134* and *clause 134* be a separate Bill, and that for the *heading before clause 134* there be substituted the following enacting words, Title clause and Commencement clause:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Child Support Amendment Act (No 2) **2003**.

2 Commencement

This Act comes into force on the day on which it receives the Royal assent.
