# Supplementary Order Paper

TRANSPORT SAFETY BILL

*Proposed Motion to Divide the Bill into 7 Bills*

Hon. W. ROB STOREY, in Committee, to move the following motion:

That *Part I* be a separate Bill, and that for *clause 2* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport Act 1962**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Transport Amendment Act (No. 3) 1992, and shall be read together with and deemed part of the Transport Act 1962 (hereinafter referred to as the principal Act).

(2) Except as provided in subsections (3) to (5) of this section, this Act shall come into force on the 1st day of April 1993.

(3) Sections 15 (1A), 17 (2), 32, and 34A of this Act shall come into force on the day on which it receives the Royal assent.

(4) Sections 9 to 14 of this Act shall come into force on the 1st day of March 1993.

(5) Section 8A of this Act shall come into force on the 1st day of July 1993.

That *Part II* be a separate Bill, and that for *clause 37* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport Services Licensing Act 1989**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement**—(1) This Act may be cited as the Transport Services Licensing Amendment Act (No. 3) 1992, and shall be read together with and deemed part of the Transport Services Licensing Act 1989 (hereinafter referred to as the principal Act).

(2) Except as provided in subsections (3) and (4) of this section, this Act shall come into force on the 1st day of April 1993.

(3) Sections 47 and 58 of this Act shall come into force on the day on which it receives the Royal assent.

(4) Section 46 of this Act shall come into force on the 1st day of September 1993.

That *Part III* be a separate Bill, and for *clause 62* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport (Vehicle and Driver Registration and Licensing) Act 1986**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Transport (Vehicle and Driver Registration and Licensing) Amendment Act 1992, and shall be read together with and deemed part of the Transport (Vehicle and Driver Registration and Licensing) Act 1986 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on a date to be appointed by the Governor-General by Order in Council; and one or more Orders in Council may be made bringing different sections into force on different dates.

That *Part IV* and the *Schedules* be a separate Bill with the following Title, enacting words, and clause:

**An Act—**

- (a) To make provisions with respect to railway safety and corridor management; and
- (b) To provide for the protection, construction, maintenance, and repair of railways; and
- (c) To consolidate and amend the law relating to railways; and
- (d) To repeal certain enactments relating to railways

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Railway Safety and Corridor Management Act 1992.

(2) Except as provided in section 100 (3) of this Act, this Act shall come into force on the 1st day of April 1993.

That *Part V* be a separate Bill, and that for *clause 102* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Transport Accident Investigation Commission Act 1990**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Transport Accident Investigation Commission Amendment Act 1992, and shall be read together with and deemed part of the Transport Accident Investigation Commission Act 1990 (hereinafter referred to as the principal Act).

(2) Except as provided in section 103A (2) of this Act, this shall come into force on the 1st day of April 1993.

That *Part VI* be a separate Bill, and that for *clause 108* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Local Government Act 1974**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Local Government Amendment Act (No. 3) 1992, and shall be read together with and deemed part of the Local Government Act 1974 (hereinafter referred to as the principal Act).

(2) This Act shall come into force on the 1st day of April 1993.

That *Part VII* be a separate Bill, and that for *clause 110* there be substituted the following Title, enacting words, and clause:

**An Act to amend the Road User Charges Act 1977**

BE IT ENACTED by the Parliament of New Zealand as follows:

**1. Short Title and commencement—**(1) This Act may be cited as the Road User Charges Amendment Act 1992, and shall be read together with and deemed part of the Road User Charges Act 1977 (hereinafter referred to as the principal Act).

(2) Except as provided in section 119 (2) of this Act, this Act shall come into force on the 1st day of April 1993.
