THE ARCHITECTS REGULATIONS 1964

ORDER IN COUNCIL

At the Government Buildings at Wellington this 23rd day of March 1964

Present:

THE RIGHT HON. KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL

PURSUANT to the Architects Act 1963, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Architects Regulations 1964.

(2) These regulations shall come into force on the 1st day of April 1964.

2. In these regulations, unless the context otherwise requires, "the Act" means the Architects Act 1963.

Applications for Registration

3. (1) Every application for registration as an architect referred to in section 19 of the Act shall be in the Form No. 1 in the Schedule hereto.

(2) Every application for registration made by a person who is the holder of a recognised certificate shall be accompanied by documentary evidence that the applicant is the holder of such a certificate.

(3) Notification of any decision of the registering authority on any application for registration may be given to the applicant by letter signed by the Registrar addressed to the applicant at the address stated by him in his application.

(4) Any document submitted with an application for registration may be returned to the applicant by post in a registered letter addressed to the applicant at the address stated by him in his application.

Registration of Architects

4. (1) The register of architects referred to in section 22 of the Act shall be kept in the Form No. 2 in the Schedule hereto.

(2) The first entries to be made in the register shall be the names of those persons who are registered pursuant to subsection (1) of section 21 of the Act. Their names shall be entered in the order in which they appear in the register of members of the Institute at the commencement of the Act.

(3) All other entries shall be made in the order in which the directions to make the entries given under subsection (2) of section 21 of the Act are received by the Registrar.

(4) The qualifications by virtue of which a person is registered shall be sufficiently indicated by the usual abbreviation of any recognised certificate (including an indication of the institution by which the certificate is granted).

(5) The alphabetical index of the names of the persons entered in the register shall be kept either in book form or by means of a loose leaf or card system, and that index shall be deemed to be a part of the register.

(6) Any direction of the registering authority shall be sufficient if it is in writing signed by the Chairman and is given pursuant to a resolution of the registering authority.

Annual Practising Certificate

5. (1) Every application for an annual practising certificate shall be made in writing in the Form No. 3 in the Schedule hereto.

(2) Every annual practising certificate issued under section 55 of the Act shall be in the Form No. 4 in the Schedule hereto.

Fees

6. (1) The fee payable on every application for registration shall be $\pounds 10 \ 10s$.

(2) The fee for a certified copy of any entry in the register shall be 5s.

(3) The fee for an annual practising certificate shall be $\pounds 3$ 3s.

(4) The fee for the restoration of a name or for the restoration of any particulars as to qualification after their removal from the register shall be $\pounds 1$ 1s.
