**ORDER IN COUNCIL**

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 45 and 50 of the Births and Deaths Registration Act 1951, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Births and Deaths Registration (Fees) Regulations 1989, Amendment No. 1, and shall be read together with and deemed part of the Births and Deaths Registration (Fees) Regulations 1989\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

**2. Further fees prescribed**—The Schedule to the principal regulations is hereby amended by adding the following items:

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force 28 days after notification in the *Gazette*, prescribe fees for the provision by the Registrar-General of copies of indexes (other than indexes relating to adoption) of information recorded under the Births and Deaths Registration Act 1951 or the Acts that preceded it. Until the passage of the Births and Deaths Registration Amendment Act 1993, which came into force on 1 July 1993, it was not possible to obtain copies of such indexes.
