



**THE EXCLUSIVE ECONOMIC ZONE (INTERIM MEASURES
FOR FOREIGN FISHING CRAFT) REGULATIONS 1977,
AMENDMENT NO. 1**

ORDER IN COUNCIL

At the Government House at Wellington this 31st day of October 1977

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 29 of the Territorial Sea and Exclusive Economic Zone Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Exclusive Economic Zone (Interim Measures for Foreign Fishing Craft) Regulations 1977, Amendment No. 1, and shall be read together with and deemed part of the Exclusive Economic Zone (Interim Measures for Foreign Fishing Craft) Regulations 1977* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of November 1977.

2. Closed areas—The Schedule to the principal regulations is hereby amended—

(a) In Part A—

(i) By omitting from item 3 the expression “north-easterly”, and substituting the expression “north-westerly”;

(ii) By omitting from item 5 the expression “a south-easterly direction to a point 40° 19.4' S and 173° 00.5' E”, and substituting the expression “a south-easterly direction to a point 40° 27.8' S and 174° 00' E”;

(b) By omitting item 2 of Part B and substituting the following item:
“2. The area enclosed by a line commencing at a point 46° 42.4' S and 169° 49.00' E; and then proceeding directly through an easterly direction to a point 46° 42.4' S and 170° 32.5' E; and then proceeding directly through a south-

westerly direction to a point 48° 20.00' S and 168° 52.00' E; and then proceeding directly through a westerly direction to a point 48° 20.00' S and 168° 05.00' E; and then proceeding directly through a north-easterly direction to the first-mentioned point."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The effect of these regulations is to revise the description of those areas that are closed to foreign fishing trawlers under the principal regulations.
