REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Fisheries (Reporting) Amendment Regulations (No. 2) 1999, and are

part of the Fisheries (Reporting) Regulations 1990\* (“the principal regulations”).

(2) These regulations come into force on 1 November 1999.

**2. Fishstock codes to be used in completing returns**—(1) Part I of the Second Schedule of the principal regulations is amended by omitting, from paragraph (b) of the note to Table 1 and also from the heading of the third column of that table, the expression “Tables 3 to 9”, and substituting in each case the expression “Tables 3 to 10”.

(2) Part I of the Second Schedule of the principal regulations is amended by inserting in Table 1, after the item relating to snapper, the following item:

“Southern blue whiting	1, 2, 3, 4, 5, 7, 8, 9, 10	SBW 1
	6A	SBW 6A
	6B	SBW 6B
	6I	SBW 6I
	6R	SBW 6R”.

(3) Part I of the Second Schedule of the principal regulations is amended by adding the Table 10 set out in the Schedule of these regulations.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 November 1999, amend the Second Schedule of the Fisheries (Reporting) Regulations 1990 to include separate area fishstock reporting codes for southern blue whiting.
