



**THE FOREST SERVICE FEES AND CHARGES REGULATIONS  
1953, AMENDMENT NO. 3**

ORDER IN COUNCIL

At the Government House at Wellington this 18th day of May 1981

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Forests Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Forest Service Fees and Charges Regulations 1953, Amendment No. 3, and shall be read together with and deemed part of the Forest Service Fees and Charges Regulations 1953\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of June 1981.

**2. Charges for draughting and technical services**—Regulation 5 of the principal regulations (as added by regulation 2 of the Forest Service Fees and Charges Regulations 1952, Amendment No. 2) is hereby amended by omitting from subclause (1) the expression “\$7”, and substituting the expression “\$15”.

**3. New Schedule substituted**—(1) The principal regulations are hereby amended by revoking the Schedule (as substituted by regulation 2 of the Forest Service Fees and Charges Regulation 1953, Amendment No. 1), and substituting the new Schedule as set out in the Schedule hereto.

(2) The Forest Service Fees and Charges Regulations 1953, Amendment No. 1 are hereby revoked.
