ORDER IN COUNCIL

At the Government Buildings at Wellington this 9th day of April 1979

Present:

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to section 29B of the Marine Pollution Act 1974 (as inserted by section 3 of the Marine Pollution Amendment Act (No. 2) 1977), His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following

ORDER

1. Title and commencement—(1) This order may be cited as the Oil Pollution Levies Order 1978, Amendment No. 1, and shall be read together with and deemed part of the Oil Pollution Levies Order 1978* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 1st day of May 1979.

2. Various levies increased—(1) The principal order is hereby amended—

- (a) By omitting from clause 3 (1) (a) the expression “150 cents”, and substituting the expression “172.5 cents”:
- (b) By omitting from clause 3 (1) (b) the expression “30 cents”, and substituting the expression “34.5 cents”:
- (c) By omitting from clause 7 (1) (a) (i) the expression “5 cents”, and substituting the expression “5.75 cents”:
- (d) By omitting from clause 7 (1) (a) (ii) the expression “2.5 cents”, and substituting the expression “2.87 cents”:
- (e) By omitting from clause 7 (1) (b) (i) the expression “1 cent”, and substituting the expression “1.15 cents”:

- (f) By omitting from clause 7 (1) (b) (ii) the expression "0.5 cents", and substituting the expression "0.57 cents":
- (g) By omitting from clause 8 (3) the expression "30 cents", and substituting the expression "34.5 cents".
- (2) Nothing in subclause (1) of this clause applies to the amount payable by way of an oil pollution levy in respect of any contributing ship where the liability to pay the levy arises, in accordance with section 29c of the Marine Pollution Act 1974, on or before the 30th day of April 1979.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order is made pursuant to the Marine Pollution Act 1974, and amends the Oil Pollution Levies Order 1978. It increases by 15 percent the rate at which certain levies are payable under the principal order. The increases do not apply in any case where the liability to pay the levy arises on or before the 30th day of April 1979.
