

THE SOUTHERN LAKES FISHING REGULATIONS 1971, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL BY HIS DEPUTY IN COUNCIL

Pursuant to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Southern Lakes Fishing Regulations 1971, Amendment No. 3, and shall be read together with and deemed part of the Southern Lakes Fishing Regulations 1971* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 9th day of August

1976.

2. Interpretation—(1) Regulation 2 (1) of the principal regulations is hereby amended by omitting from paragraph (d) of the definition of "open season" the words "and Mill Creek (which flows into Lake Hayes),", and substituting the words ", Mill Creek (which flows into Lake Hayes), and the hydro-electric outfall from Lake Manapouri into Deep Cove, Doubtful Sound,".

(2) The said regulation 2 (1) is hereby further amended by adding, to the definition of "open season" (as amended by subclause (1) of this

regulation), the following paragraph:

'(e) In respect of Diamond Creek between its confluence with the Rees River (as indicated by a black and white striped marker post) and its outflow from Reid Lake, the 1st day of October in any year to the 31st day of March in the next succeeding year (both days inclusive):".

*S.R. 1971/65 Amendment No. 1: S.R. 1973/20 Amendment No. 2: S.R. 1974/5 3. Rights to fish conferred by licences—Regulation 10 (1) of the principal regulations is hereby amended by revoking paragraph (f), and substituting the following paragraph:

"(f) That portion of Lake Wakatipu that is within 100 m of any part of the wharf in Black Bay (commonly known as the Walter

Peak Jetty):".

4. Fishing licence fees increased—(1) The principal regulations are hereby amended by revoking the Third Schedule (as substituted by regulation 4 of the Southern Lakes Fishing Regulations 1971, Amendment No. 2), and substituting the Third Schedule set out in the Schedule to these regulations.

(2) Regulation 4 of and the Schedule to the Southern Lakes Fishing Regulations 1971, Amendment No. 2 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Southern Lakes Fishing Regulations 1971—
(a) By removing the restrictions on fishing near the hydro-electric outfall into

Deep Cove:
(b) By shortening the open season in respect of Diamond Creek:

(c) By restricting fishing within 100 metres of the Walter Peak Jetty in Lake
Wakatipu:

(d) By increasing fees (except the fee payable for a weekly licence).
