## ORDER IN COUNCIL

### HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Social Security Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title—These regulations may be cited as the Social Security (Maternity Benefits) Regulations 1939, Amendment No. 14, and shall be read together with and deemed part of the Social Security (Maternity Benefits) Regulations 1939\* (hereinafter referred to as the principal regulations).

2. Amount of fees—(1) The principal regulations are hereby amended by omitting from the Schedule (as substituted by regulation 4 of the Social Security (Maternity Benefits) Regulations 1939, Amendment No. 12) the expression "\$9" (as substituted by regulation 2 of the Social Security (Maternity Benefits) Regulations 1939, Amendment No. 13), and substituting the expression "\$12".

(2) The Social Security (Maternity Benefits) Regulations 1939, Amendment No. 13, are hereby revoked.

**3.** Application of regulations—(1) These regulations shall apply with respect to maternity benefits afforded on or after the 1st day of October 1975.

(2) In all other cases the principal regulations shall apply as if these regulations had not been made.

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the daily fees payable to licensees of licensed maternity hospitals from \$9 to \$12 as from 1 October 1975.
