

THE SOCIAL SECURITY (DENTAL BENEFITS) REGULATIONS **1983. AMENDMENT NO. 9**

PURSUANT to sections 116, 123 (2), and 132 of the Social Security Act 1964, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title, commencement, and application—(1) These regulations may be cited as the Social Security (Dental Benefits) Regulations 1983, Amendment No. 9, and shall be read together with and deemed part of the Social Security (Dental Benefits) Regulations 1983* (hereinafter referred to as the principal regulations).

- (2) These regulations shall be deemed to have come into force on the 1st day of April 1991, and shall apply to dental services provided on or after that date.
- 2. Application of regulations—Regulation 4 (1) of the principal regulations is hereby amended by revoking paragraphs (c) and (d) (as substituted by regulation 2 of the Social Security (Dental Benefits) Regulations 1983, Amendment No. 8), and substituting the following paragraphs:

"(c) Aged 16 or 17 years and in respect of whom any one of the

following benefits is payable under the Act:

"(i) An orphan's benefit:

"(ii) An unsupported child's benefit:

"(iii) An invalid's benefit:

"(iv) A training benefit:

"(v) A job search allowance:

"(vi) An independent youth benefit:

"(vii) An emergency benefit; or

- "(d) Aged 16 or 17 years and who is undertaking a course of study which is a full-time programme as defined in the Student Allowances Regulations 1988*."
- **3. Revocation**—The Social Security (Dental Benefits) Regulations 1983, Amendment No. 8 are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which are deemed to have come into force on 1 April 1991, amend the Social Security (Dental Benefits) Regulations 1983 by re-defining the classes of persons aged 16 or 17 years entitled to dental benefits.

The re-definition is made necessary by the abolition of the family benefit.
