# **Environmental Protection Authority Bill**

Proposed motion to divide Bill into 6 Bills

Hon Dr Nick Smith, in Committee, to move as follows: That the enacting words, *clauses 1 and 2*, *Parts 1 to 3 and 7*, *and Schedules 3 to 7* be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1* heading there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

1 **Title** This Act is the Environmental Protection Authority Act **2011**.

#### 2 Commencement

- (1) Parts 1 and 2 of this Act come into force on the day after the date on which it receives the Royal assent.
- (2) The rest of this Act comes into force on a date appointed by the Governor-General by Order in Council; and 1 or more orders may be made bringing different provisions into force on different dates.
- (3) Any provision that has not earlier been brought into force comes into force on 1 December 2012.

That *Part 4* and *Schedule 1* be a separate Bill, and that for the *Part 4* heading and *clause 48* there be substituted the following enacting words and clauses:

#### The Parliament of New Zealand enacts as follows:

1 Title This Act is the Climate Change Response Amendment Act 2011.

#### 2 Commencement

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council; and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provision that has not earlier been brought into force comes into force on 1 December 2012.

#### **3** Principal Act amended

This Act amends the Climate Change Response Act 2002.

That *Part 5* and *Schedule 2* be a separate Bill, and that for the *Part 5* heading and *clause 65* there be substituted the following enacting words and clauses:

This Act is the Hazardous Substances and New Organisms Amendment Act **2011**.

#### 2 Commencement

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council; and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provision that has not earlier been brought into force comes into force on 1 December 2012.

# **3** Principal Act amended

That *Part 6* be a separate Bill, and that for the *Part 6* heading and *clause 75* there be substituted the following enacting words and clauses:

This Act is the Resource Management Amendment Act 2011.

- (1) This Act comes into force on a date appointed by the Governor-General by Order in Council; and 1 or more orders may be made bringing different provisions into force on different dates.
- (2) Any provision that has not earlier been brought into force comes into force on 1 December 2012.

# **3** Principal Act amended

This Act amends the Resource Management Act 1991.
