Criminal Procedure Bill

Proposed motion to divide Bill into 6 Bills

Hon Mark Burton, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2* and *Part 1* be a separate Bill, and that for the enacting words, *clauses 1 and 2*, and the *Part 1 heading* there be substituted the following enacting words and clauses:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Crimes Amendment Act **2007**.

2 Commencement

- (1) **Section 5** comes into force on the day that is 6 months after the date on which this Act receives the Royal assent
- (2) The rest of this Act comes into force on the day after the date on which this Act receives the Royal assent.

That *Part 2* and *Schedules 1 and 2* be a separate Bill, and that for the *Part 2 heading* and *clause 17* there be substituted the following enacting words and clauses:

The Parliament of New Zealand enacts as follows:

1 Title

This Act is the Criminal Disclosure Act **2007**.

2 Commencement

This Act comes into force on a date to be appointed by the Governor-General by Order in Council.

That *Part 3* and *Schedule 3* be a separate Bill, and that for the *Part 3 heading* there be substituted the following enacting words and clauses:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the District Courts Amendment Act **2007**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 4* be a separate Bill, and that for the *Part 4 heading* there be substituted the following enacting words and clauses:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the Juries Amendment Act **2007**.

2 Commencement

(1) This Act (except **sections 68, 75, 76, and 82A**) comes into force on the day that is 6 months after the date on which this Act receives the Royal assent.

(2) **Sections 68, 75, 76, and 82A** come into force on a date to be appointed by the Governor-General by Order in Council; and 1 or more Orders in Council may be made appointing different dates for different provisions.

That *Part 5* and *Schedules 4 to 6* be a separate Bill, and that for the *Part 5 heading* there be substituted the following enacting words and clauses:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the Summary Proceedings Amendment Act **2007**.

2 Commencement

(1) This Act (other than this section and **sections 84, 88 to 91, 92A, and 93**) comes into force on a date to be appointed by the Governor-General by Order in Council.

(2) This section and **sections 84, 88 to 91, 92A, and 93** come into force on the day after the date on which this Act receives the Royal assent.

That *Part 6* be a separate Bill, and that for the *Part 6 heading* there be substituted the following enacting words and clauses:

The Parliament of New Zealand enacts as follows:**1 Title**

This Act is the Victims' Rights Amendment Act **2007**.

2 Commencement

This Act comes into force on the day after the date on which it receives the Royal assent.
