## Te Hiku Claims Settlement Bill

*Proposed motion to divide Bill into 6 Bills*

Hon Christopher Finlayson, in Committee, to move as follows:

That the enacting words, *clauses 1 and 2, Parts 1 to 3, and Schedules 1 to 5* be a separate Bill, and that the enacting words and *clauses 1 and 2* be replaced with:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Ngāti Kuri Claims Settlement Act **2015**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Parts 4 to 7 and Schedules 6 to 11* be a separate Bill, and that above the *Part 4* heading there be inserted:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Te Aupouri Claims Settlement Act **2015**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Parts 8 to 10 and Schedules 12 to 16* be a separate Bill, and that above the *Part 8* heading there be inserted:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Ngāi Takoto Claims Settlement Act **2015**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Parts 11 to 13* and *Schedules 17 to 22* be a separate Bill, and that above the *Part 11* heading there be inserted:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Te Rarawa Claims Settlement Act **2015**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 14* be a separate Bill, and that the *Part 14* heading be replaced with:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Ngāti Kahu Accumulated Rentals Trust Act **2015**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.

That *Part 15* be a separate Bill, and that the *Part 15* heading be replaced with:

**The Parliament of New Zealand enacts as follows:**

**1 Title**

This Act is the Reserves and Other Lands Disposal Act 1977 Amendment Act **2015**.

**2 Commencement**

This Act comes into force on the day after the date on which it receives the Royal assent.
