

NORTHERN INDUSTRIAL DISTRICT **SHIPWRIGHTS AND BOATBUILDERS**—AMENDMENT
OF AWARD

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Regulations 1952; and in the matter of the Northern Industrial District Shipwrights and Boatbuilders award, dated the 4th day of January 1951, and recorded in 51 Book of Awards 33.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Regulations 1952, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of July 1952, doth hereby order as follows:—

1. That the said award shall be amended in the manner following:—

(1) By deleting clause 3 and substituting the following clause:—

“ *Wages*

“ 3. (a) The minimum rate of wages for journeymen shipwrights and boatbuilders shall be 5s. 1 $\frac{3}{4}$ d. per hour.

“ (b) Leading hands shall be paid 5 $\frac{1}{4}$ d. per hour above the wage rate herein prescribed.”

(2) By inserting after clause 27 the following new clause:—

“ *Exclusion from Operation of General Order*

“ 28. The rates of remuneration provided for in this award shall *not* be subject to the provisions of the general order of the Court, dated the 30th January 1951, and made under the Economic Stabilization Regulations 1950.”

(3) By deleting from the undermentioned clauses the figures and symbols set out in the first column hereunder and substituting in each case the figures and symbols respectively set out in the second column hereunder :—
