

ECONOMIC STABILISATION REGULATIONS 1953—EXCLUSIONS FROM OPERATION
OF GENERAL ORDER OF 5 AUGUST 1968

In the Court of Arbitration of New Zealand, Otago and Southland Industrial District—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the Economic Stabilisation Regulations 1953.

In pursuance and exercise of the powers conferred on it by regulation 4 (1) of the Economic Stabilisation Regulations 1953, and upon applications made in that behalf, the Court doth hereby order as follows:

1. That the provisions of the general order of the Court made under the said regulations and dated the 5th day of August 1968 shall not apply to the under-mentioned industrial agreements and the workers whose employment is subject to the said industrial agreements are hereby excluded from the operation of that general order:

Dunedin City Council Waterworks Caretakers Industrial Agreement, dated the 22nd day of May 1967 – Registered No. 734 (67 Book of Awards 1227).

Dunedin City Council and Dunedin Drainage and Sewerage Board Clerical and Other Employees Industrial Agreement, dated the 27th day of October 1966 – Registered No. 718 (66 Book of Awards 2249).

Dunedin City Council and Dunedin Drainage and Sewerage Board Inspectors Industrial Agreement, dated the 31st day of October 1966 – Registered No. 719 (66 Book of Awards 2457).

Dunedin City Council Moana Pool Employees Industrial Agreement, dated the 4th day of November 1966 – Registered No. 717 (66 Book of Awards 2757).

Dunedin City Council Female Workers (Botanic Gardens) Industrial Agreement, dated the 19th day of April 1968 – Registered No. 759.

Dunedin City Council Librarians and Their Assistants Industrial Agreement, dated the 15th day of July 1968 – Registered No. 762.

Dunedin City Council Electricity Department Employees Industrial Agreement, dated the 31st day of March 1967 – Registered No. 725 (67 Book of Awards 524).

Dunedin City Council Linesmen, Linesmen's Assistants and Electricians Industrial Agreement, dated the 10th day of October 1966 – Registered No. 714 (66 Book of Awards 2464).

Dunedin City Council and Dunedin Drainage and Sewerage Board Engineer Officials Industrial Agreement, dated the 1st day of September 1966 – Registered No. 712 (66 Book of Awards 2091).

2. That this order shall be deemed to have come into force on the 19th day of August 1968.

MEMORANDUM

This order results from several applications under regulation 4 (1) of the Economic Stabilisation Regulations 1953 and corresponds with exclusions made for the same reason subsequent to other general orders.

The special grounds stated in accordance with regulation 4 (3) are common to each application, and are to the effect that exclusion from the operation of the general order of the Court is necessary because it has been agreed by the respective parties that the wage or salary rates to be paid by the authorities concerned shall be related to the rates operating in the State Services and shall be amended from time to time to reflect any variations made by the State Services Commission following ruling rates surveys taken under section 42 of the State Services Act 1962.
