NORTH AND SOUTH CANTERBURY HOSPITAL BOARDS CLERICAL EMPLOYEES—VARIATION OF INDUSTRIAL AGREEMENT

By this industrial agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954, this 26th day of February, 1968, between the North Canterbury Hospital Board and the South Canterbury Hospital Board (hereinafter called the "board") of the one part and the Canterbury Clerks', Cashiers' and Office Employees' Industrial Union of Workers (hereinafter called the "union") of the other part, it is mutually agreed that the industrial agreement made between the said parties on the 9th day of November, 1966 as it stands now varied by industrial agreement made between the said parties on the 15th day of August, 1967 shall be, and is hereby varied in the manner following, that is to say:

By deleting from the undermentioned clauses the figures and symbols set out in the first column hereunder and substituting in each case the figures and symbols respectively set out in the second column.

And by deleting clause 6(F)—Overtime and substituting the following:

(F) That total overtime payment in respect of any year shall be restricted to an amount which, when added to the salary for that year, does not exceed \$3.030.

Provided, that where an officers' salary is such that the addition of overtime increases his total earnings in any one year in excess of \$3,060 he may receive overtime up to a maximum of 10 percent of his salary.

Provided further that in no case shall his total earnings when increased by overtime exceed \$3,720.

This agreement shall be deemed to have taken affect on the 1st day of April, 1967.
