To amend the Canberra University College Ordinance 1953.

CANBERRA UNIVERSITY COLLEGE ORDINANCE 1957. Short title and citation.

- 1.—(1.) This Ordinance may be cited as the Canberra University College Ordinance 1957.*
- (2.) The Canberra University College Ordinance 1953† is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Canberra University College Ordinance* 1953-1957.
 - 2. Section eleven of the Principal Ordinance is amended— $\frac{Constitution of Council}{Council}$ of the following para-

(a) by inserting after paragraph (c) the following paragraph:—

" (ca) the Deputy Chairman of the Board of Studies, if he is not a member by virtue of paragraph (e) or (f) of this sub-section;"; and

- (b) by adding at the end thereof the following subsection:—
 - "(2.) For the purposes of this section, the Librarian of the College (being a university graduate) and the Assistant Librarian of the College (being a university graduate) shall be deemed to be full-time members of the teaching staff of the College."

Person not to be a member in more than one capacity. 3. Section twelve of the Principal Ordinance is amended by inserting after the word "paragraphs" the words "of subsection (1.)".

Term of office of members and vacancies.

4. Section thirteen of the Principal Ordinance is amended by omitting from sub-section (3.) the words "a member" (wherever occurring) and inserting in their stead the words "an elected or appointed member".

Meetings of the Council.

- 5. Section seventeen of the Principal Ordinance is amended by adding at the end thereof the following sub-section:—
 - "(5.) At a meeting of the Council—
 - (a) all questions shall be decided by a majority of the votes of the members present and voting; and
 - (b) the Chairman or member presiding has a deliberative vote and, in the event of an equality of votes, also has a casting vote.".

Board of Studies.

- 6. Section nineteen of the Principal Ordinance is amended by omitting sub-section (2.) and inserting in its stead the following sub-sections:—
- " (2.) The Board of Studies shall consist of the Principal of the College, the professors of the College and such other persons as the Council determines.
- "(2A.) The Principal of the College shall be the Chairman of the Board of Studies.
- "(2B.) The Board of Studies shall elect one of its members to be the Deputy Chairman of the Board of Studies and the member so elected holds office during the pleasure of the Board."
